In 2007, influenced by the Cheshire home invasion, the State of Connecticut undertook a review of its criminal justice process. As a result of that review, State of Connecticut Public Act 08-01 (P.A. 08-01) was passed. P.A. 08-01 not only provided for change to the penal code, it also provided for change to the current criminal justice information sharing process in an effort to provide for a safer community for the citizens of the State.
- 9. Justification: The funds are requested to complete the CISS project implementation to 13,000 users statewide, implement electronic workflows with nine Criminal Justice Agencies, replace paper based workflows, add required information exchanges, complete router connectivity with all police departments and State Police as well as complete the interface with Record Management Systems (RMS) to send police uniform arrest reports electronically. Without this deployment of what has been built and put into production as of this date, CISS will not be able to be used in the manner as originally intended to improve public and law enforcement safety along with the envisioned tangible benefits projected at about fifteen million dollars in annual savings.
