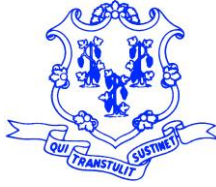

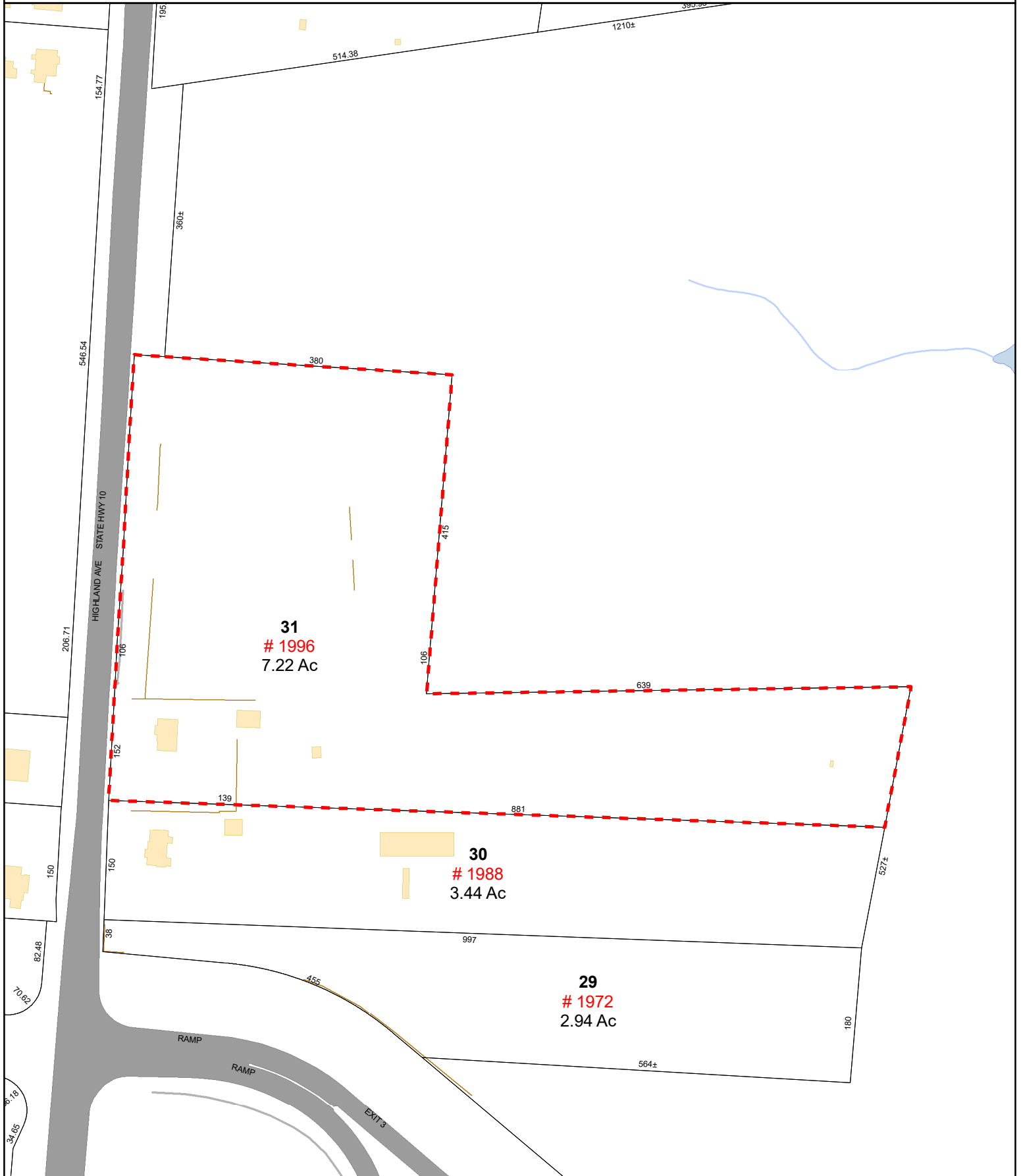

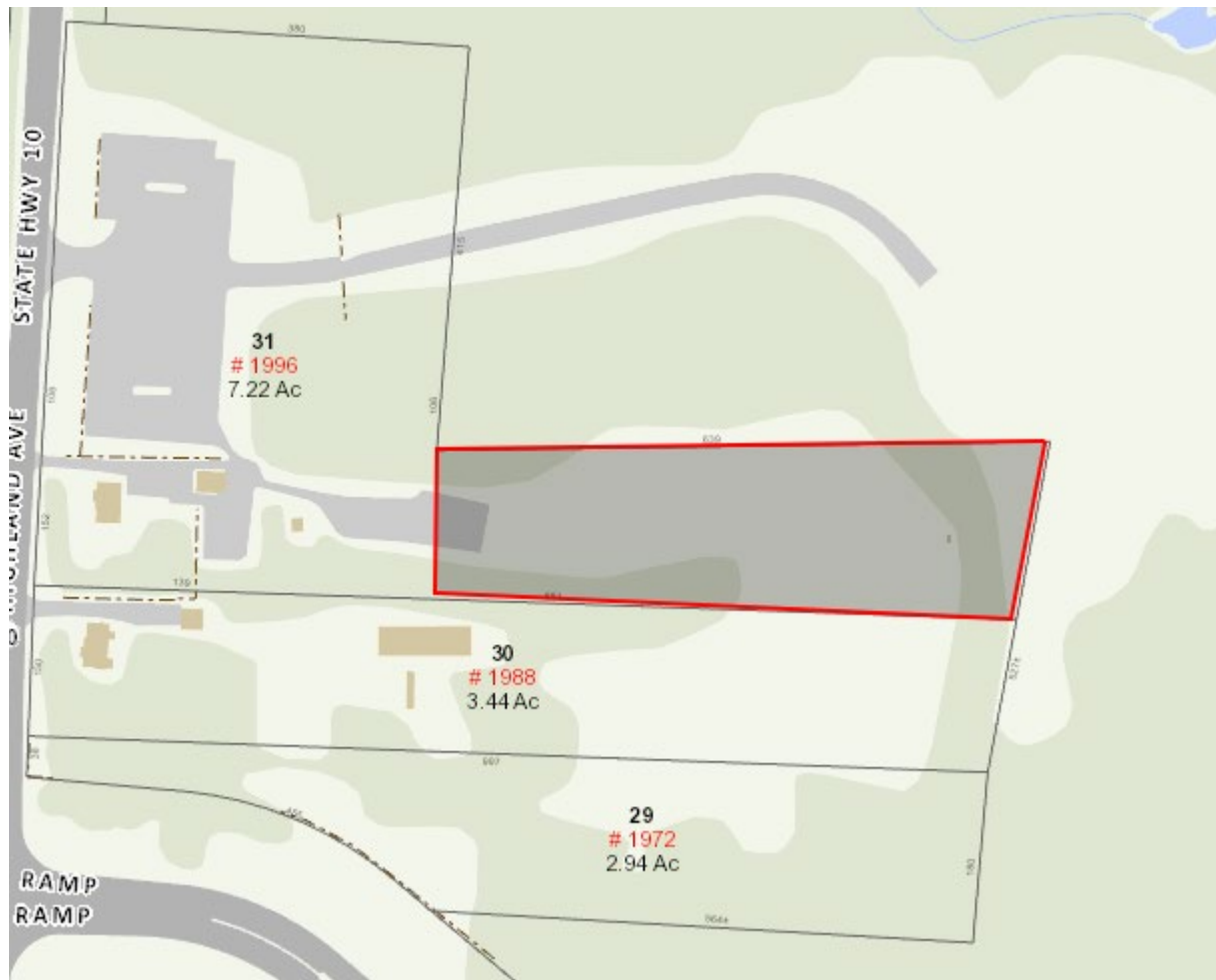
Location: 1996 HIGHLAND AVE

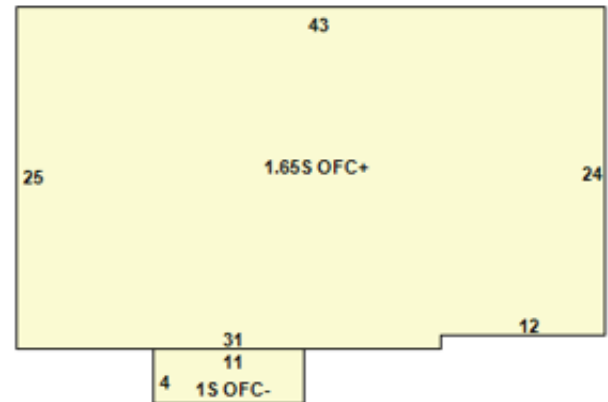
