


**Report to the General Assembly's General Law Committee pursuant to  
Public Act 14-210,  
“AN ACT CONCERNING THE ENFORCEMENT OF CERTAIN  
OCCUPATIONAL LICENSING STATUTES”**

This report is submitted pursuant to CGS Sec. 21a-8 (b): **Department's and commissioner's powers and duties re boards and commissions.**

*(b) Not later than January 15, 2015, and annually thereafter, the commissioner, in accordance with section 11-4a, shall report the following to the joint standing committee of the General Assembly having cognizance of matters relating to consumer protection and occupational licensing: (1) The total number of complaints received by the department in the previous calendar year concerning the work and practice of persons licensed, registered or certified by the boards or commissions specified in subdivisions (1) and (3) of section 21a-6, (2) the nature of each complaint, (3) the department's resolution of each complaint, including, if applicable, whether the complaint (A) was dismissed because the allegation, if substantiated, would not constitute a violation of any statute or regulation, (B) was investigated, (C) was dismissed, following an investigation, for lack of probable cause, (D) was resolved by a settlement, and whether a penalty was imposed pursuant to such settlement, or (E) was brought for formal hearing, and whether a violation was found and a penalty imposed.*

This report will provide complaint information pertaining to the boards and commissions included in the statute, specifically those specified in subdivisions (1) and (3) of section 21a-6:

- (1) The Architectural Licensing Board established under chapter 390;
- (3) The examining boards for electrical work; plumbing and piping work; heating, piping, cooling and sheet metal work; elevator installation, repair and maintenance work; fire protection sprinkler systems work and automotive glasswork and flat glass work established under chapter 393;

This report covers complaints filed with the Department of Consumer Protection for the calendar year 2015. Complaints received are reviewed and investigated by the Department's Trade Practices Division.

A summary of each complaint is attached via spreadsheet. For each complaint, the spreadsheet contains the case number, the occupational license type, the current status of the complaint, the nature of the complaint, the date the complaint was received by the Department, the date the Department closed the complaint (if applicable), and the resolution.

Please see appendix A for complaints pertaining to 21a-6 (1) and appendix B for complaints pertaining to 21a-6 (3).
