Connecticut Alcoholic Beverages Tax & Comparison



ALB Tax Information

- A licensed Alcoholic Beverage Distributor collects the Alcoholic Beverages Tax on taxable sales in CT and remits such tax on a monthly basis via Form O-255 Wholesale Alcoholic Beverages Tax Return.
- Limited number of exceptions to the tax, which are enumerated in §12-453, and includes products that are not sold as a beverage for human consumption. Additionally malt beverages which are consumed on the premises covered by a manufacturer's permit (Brew Pub).

ALB Tax Information cont.

- Potential applicants to be licensed as an alcoholic beverage distributor must first apply with the Liquor Control Division of the Dept. of Consumer Protection for the appropriate permit(s).
- Connecticut has a total of 482 licensed Alcoholic Beverage Distributors of which 38 are mandated electronic filers. The majority of these licensees (approximately 85%) are wineries from across the country that ship wine directly to persons located in Connecticut.

ALB Tax Information cont.

The Alcoholic Beverages Tax originates at the distributor level and is passed to the retail level. At the retail level, a sales tax of 6.35% is also included. Both taxes are then passed onto the consumer.
