DIVORCE TO JENNIE W. BANKS.

Wife of Probate Judge Banks of Fairfield County, Conn.

CHICAGO, Dec. 24.—Judge Ewing to-day granted a decree of divorce to Jennie W. Banks, the wife of Judge Elmore S. Banks, who presides in the Probate Court of Fairfield, Conn.

The divorce was granted on the ground of cruelty

The couple were married in February, 1889. Mrs. Banks left her husband in 1893, and took up her residence in Chicago.

and took up her residence in Chicago. According to the evidence given by the complainant, her husband struck her within two weeks after the marriage, and seven years ago struck her and shot her in the face.

The trouble which led up to the shooting, according to the complainant, arose from the fact that she had purchased a hat with large plumes. The Judge expressed his displeasure when he saw the hat, and objected to the plumes being worn by his wife. Words led to blows, and finally to the use of a firearm.

On another occasion, the complainant said, her husband became displeased at her at a card party given at their home, and struck her in the face. About two weeks before she left her husband, she testified, he pushed her down the stairs, and after that she determined to leave him.
