In 2013, the university affirmed that in order to comply with state and federal law, all staff and faculty members are required to attend training on understanding and preventing harassment; this training is directly connected to Wesleyan's [Policy Prohibiting Discriminatory Harassment and Sexual Misconduct](#) implemented in the fall of 2015. While we are getting closer to our goal of 100%, we are not there yet.

With this e-mail, we announce a schedule of training sessions for Summer 2018, bringing the total to 60+ sessions offered since 2014. Many thanks to those of you who have previously attended this training; you are not expected to attend these sessions, although upcoming changes in the law will require recurring additional training. The program provides training and education related to harassment awareness and prevention as required by Connecticut law. In addition, it provides information on discriminatory harassment under Title VII of the Civil Rights Act and Title IX of the Education Amendments of 1972, which prohibits discrimination on the basis of sex in education programs or activities receiving Federal financial assistance. Finally, the program provides conversation about fostering a respectful and inclusive campus environment.
