## **LET'S HYPOTHESIZE...**

**Scenario**: You go to doctor's office for a special X-Ray that is crucial for a diagnosis

• The doctor says:

"Nope, can't do it. Might be good for you, but it's not convenient for me."

- How would you feel?
  - Here are some words for you: Enraged, oppressed, marginalized
- **11%** of Connecticut's population face this scenario

# WHAT I DID:

- 1. Investigated the 29 hospitals in CT
- 2. Contacted medical professionals
- 3. Spoke with remarkable people with disabilities

We need to create policies for disability friendly services in health care facilities and ensure appropriate medical diagnostic equipment.

## **THE MAP**

- I made a website with a map of hospitals in CT
- If you click each location, you can see description of hospital and what accommodations for people with disabilities they claim to have
- The information they provided can be misleading → hospitals want to be portrayed in good light

- Interviewed people with disabilities from New Horizons Village
- Interviewed Medical experts
  - Dr. Peter Deckers: former dean of UCONN health
  - Dr. Mary Beth Bruder: professor at UCONN health, works for Center for Excellence in Developmental Disabilities (CEDD)





# JAY TULIN

- Caretaker of late wife, Nancy
- Nancy was in wheelchair for disability + disease + weight issues
- Nancy went to doctor's office, doctor said:

"You can't get on my exam table, you'll break it!"

# RACHEL

- Has cerebral palsy
- Never saw wheelchair scale at any doctor's office
  - Except one time, but they didn't use it
- Never received proper mammogram
  - Except one when there was a properly trained technician

"I can't remember the last time I was on an exam table."

## **SUZANNE**

- Given ultrasounds instead of mammograms ← ultrasounds are not the right process for breast examination, mammograms are
- Doctor's office even said:

"We no longer take wheelchairs. If you can't talk in for the visit, we can't have you here."

# JAMIE

- Never taken onto an examination table
- Doctors told him that

"Blood work tells you everything."

This is not true.

• Sores/crucial issues cannot be checked

## **THERE ARE SO MANY SIMILAR STORIES...**

- Inaccessible mammograms, lifts, or special scales are examples of technical limitations and disadvantages
- Most common complaints: not enough wheelchairs in doctors' offices and medical professionals who are not trained well enough to accommodate people with disabilities

## **OUR NEXT STEPS...**

We must make legislation/rules that health care institutes must abide to
Inequity in healthcare is too prevalent
