Members voiced their concerns about which would be appropriate for Connecticut residents, medical tailored meal options versus a prescription food programs. Rep. Foster asked for members to give on these 4 bill examples via email. A presentation was given by Max Perkins from Unite Us titled "Leveraging Digital Social Care Infrastructure to Facilitate Access to Food & Nutrition Services."
