# Status Report -- Judicial Branch's Implementation of P.A. 08-1 of the January Special Session and P.A. 08-51

The following charts detail the status of the Judicial Branch's implementation of P.A. 08-1 of the January Special Session and P.A. 08-51:

#### PUBLIC ACT 08-51 AAC Persistent Dangerous Felony Offenders and Providing Additional Resources to the Criminal Justice System

1 (upon passage)	Amends the persistent dangerous felony offender statute to provide for longer sentences	Implemented
2 (from passage)	<ul> <li>Requires prosecutors to make certain statements on the record in persistent dangerous felony offender cases</li> <li>Prohibits the court from accepting a plea of guilty, not guilty or nolo contendere from any person unless the prosecutor has complied with these requirements</li> </ul>	Implemented
Sec 5 (effective July 1, 2008)	Provides funding for additional court staff, prosecutors and public defenders, as well as enhancement of probation supervision	See detail below

#### **Description**

- This Section of the Act provides the Judicial Branch with personnel and funds to increase access to and production of transcripts; to increase supervision services for sex offenders through caseload size reduction and day reporting services for homeless sex offenders; increased use of polygraph examinations and increased use of GPS units; to increase the capacity to serve warrants for violation of probation and to create new programs to reduce juvenile truancy and to provide pilot intervention projects to juveniles at risk of becoming delinquents.
- Of the 70 positions and \$5,232,000 appropriated to the Judicial Branch to support this Section, 50 positions and \$4,040,000 were assigned to CSSD, for FY 09, as follows:

#### Present Plans

SEX OFFENDER SUPERVISION

- Execute contract in October, 2008 for polygraph service expansion beginning in November, 2008.
- Identify sex offender criteria and cases for GPS supervision beginning April, 2009.

### WARRANT SERVICE

• Train new Warrant Service Officers and deploy in January, 2008 to increase number of warrants served in more efficient time frames.

### MONITORING OF HOMELESS SEX OFFENDERS

• Start New Haven resource coordinators and clinician no later than Nov., 2008. Resolve Hartford location issue for project start in early 2009.

MANDATED PRE-SENTENCE INVESTIGATIONS FOR SEX OFFENDERS

• Hire and train necessary staff for Jan., 2009 start-up.

EXPEDITED EVALUATION AND PRE-RELEASE SERVICES FOR SEX OFFENDERS

• Complete staff hiring and training for Oct., 2008 start. Complete policies and procedures for

identification and assignment of sex offenders to contracted clinicians to allow for evaluation of sex offenders three to six months prior to release to probation from incarceration.

TRUANCY PREVENTION PROGRAM

• Will be implemented by the Institute for the Study of Crime and Justice, CCSU.

JUVENILE JUSTICE URBAN CITIES PROGRAM

• Issue contracts with identified agencies/institutions in November for December, 2008 start-up.
