

To: CT General Assembly's Judiciary Committee:

Hello - and believe me when I say that - that I really mean "Hell is low and I am in it!!" Thanks to police brutality by the Meriden police department - I have been left HOMELESS for 6 1/2 years with a broken back and fractured sternum - after being forcefully-evicted from my OWN inheritance property (left to me in my Great Grandmother's original Will/Deed.)

The Meriden police broke my back in 4-5 places brutalizing me after I had requested ADA accommodations to be allowed to use my medical walker, these dirty cops split my sternum (the strongest bone in the human body), and tortured me at the Meriden police station for 2 1/2 days. They laughed like a pack of jackals!! These sadistic psychos need to be locked up in prison or a nut house. (The police chief's son - also a dirty cop - WAS finally thrown into prison - Cossette

Then, I was denied my right to bail out on a mere \$50 bail - and sent to the YCI Niantic prison, where I was further tortured for 3 weeks. I was repeatedly told: "If you voluntarily waive your right to the Inheritance Property, you will be set free." I filed a Writ of Habeas Petition - See Schipke v. Fulcher - [https://www.govinfo.gov/app/details/USCOURTS-ctd-3\\_16-cv-02096](https://www.govinfo.gov/app/details/USCOURTS-ctd-3_16-cv-02096) - which was absolutely worthless in the corrupt courts.

My name is Mary Elizabeth Schipke, 63, of the Meriden Schipke Family. Many of my deceased family members names grace numerous Military Walls of Honor. In Meriden: my mother Marguerite Marie Schipke, (Lt. Officer - Navy), my uncle Andrew Schipke (28 years - Sgt Major - Marines); my two cousins Raymond and Thomas (doctors in Army - Purple Heart recipients), in Wallingford: 4 great uncles names on military wall.

I have 183 ancestors buried at St. Boniface Cemetery and another 35 across the fence in Walnut Grove Cemetery. I have other family members, one who was Captain of the Fire Department buried in Wallingford at the In Memorium Cemetery. In Wallingford, the Frederick Schipke gymnasium is named after another ancestor. Needless to say, my family has paid a high price to serve this country.

But because of criminals in Meriden, I was subjected to "Inheritance Hijacking" and my inheritance Ancestral Family Home was forcefully stolen from me. My life-or-death case was just slammed through the corrupt courts.

When the Meriden police officer forcefully-evicted me from my OWN property (this grossly violated International Human Rights law -

## "Forced Evictions -

Forced evictions constitute gross violations of a range of internationally recognized human rights, including the human rights to adequate housing, food, water, health, education, work, security of the person, freedom from cruel, inhuman and degrading treatment, and freedom of movement."

To add insult to injury, I was criminally charged with bogus criminal charges for being on my OWN Inheritance property:

I legally DEMANDED SPEEDY TRIAL - and my trial has been set for December 31, 2030. (See: N07M-CR16-0289796-S)
