Dear Legislator,

I am writing to you in opposition of the legislative bill LCO # 3471. I am asking you to think of the greater good and all of your constituents when voting. I could list all of the heroic actions I have witnessed the police perform but this email would go on forever. These violent crimes and awful things are not going to stop, but i can guarantee you they are going to get worse if this bill passes. You will see a record number of these heroic officers hand in their badges and walk away. Who do we call then?

I am scared for our future. It feels like the decisions being made at the government level are so out of touch with reality and the real world impact this will have. Please vote no for this bill. Please keep the qualified immunity to protect the citizens who live here. I do not want to think about how dangerous this world, this state will be when all the good officers have to leave to protect their families from the frivolous lawsuits and financial ruin.
