Protocol: Meeting was called to order at 10:00am. Chairperson Cousineau advised of the emergency evacuation procedures for hearing room 2B.

Introduction: For the benefit of the members and the public, each member introduced themselves and explained their background.

Minutes of the Oct. 31, 2013 meeting: A motion to accept the minutes was made by Joe DiTunno and seconded by Attorney Allard. Minutes were accepted.

Procedure for Receiving Public Comments: Chairperson Dornfeld explained the protocol for receiving public comments. The email address for the task force is LDCC@cga.ct.gov . The members agreed that it would be helpful to be able to read the comments as they come in to avoid having to catch up with a large number at the time of the hearing. The task force staff will check with the IT department on whether comments sent to LDCC@cga.ct.gov could be automatically forwarded to the members' personal email addresses. Any comments sent directly to a task force member should receive a reply from the task force member advising the sender to send their comments to the task force's email address.

Role of a guardian ad litem and the attorney for a minor child in any action involving parenting responsibilities and the custody and care of a child: Discussion with the task force members included examination of:

- The duties of GALs and AMCs
- The need for GALs to obtain experience and have continuing education
- The benefits of GAL representation during custody proceedings
- Possible task force recommendations to tackle the issue of cost of GALs to the parties
- Whether the task force should look into and suggest that the legislature clarify the statutory role of AMCs and GALs

- The issue of uniform standards for AMC's and GALs
- The minimum standard requirements for appointment and duties of GALs
- The issue of background checks for GALs during appointment process
- The issue of duration of GALs appointments
- Appointment of Guardian Ad Litem forms

Timeline & Scheduling:
