My name is Nathan Cloutier and I am here to express how important it is for children to have equal access to both parents. Children do not play favorites when it comes to their parents and neither should our courtrooms. I have a 4 1/2 year old daughter whom I love more then anything in the world. It took me 2 1/2 years and \$30,000 to eventually see my child 2 days a week. Because of a hostile parent who did everything she could to eliminate or reduce my daughter's time with me, I was forced to go through parental alienation, heart breaking mental duress, and a considerable amount of money. These facts pale however in comparison to seeing my daughter's eyes not able to understand why she cannot stay any longer with her father. That is the real punishment. And it falls on her. Her right to be with both parents equally is violated.

I do not understand why one parent is able to control the lack of equal time allotment with their mutual child, and why it is so easy to do so. I understand that there are some parents that, for safety's sake, may need some involvement from our court system. But if a parent is fit, why shouldn't our children have the option of spending equal time with each of them?

In my case, in the end when the judge asked my daughter's mother why our daughter shouldn't spend more time with her father, her response was simply that I "am a disruption to their routine". As unparent-like as that may sound, Judge Robert Malone decided that was enough for him to not consider a 50/50 shared parenting situation. I signed up to be a dad. I want to be an equal part of the routine. Even our daughter's GAL and our family services case worker both recommended equal time for my daughter and I commencing upon the start of kindergarten which is approaching this fall 2014. This was to be a defining future provision of our parenting plan. Instead, Judge Malone, our lawyers, and our GAL, went literally behind closed doors, and decided my daughter's fate. Instead of immediate 50/50 shared parenting, my daughter was awarded 2 days a week with her father. Instead of a 50/50 future provision, the provision was thrown out. I am now doomed to another round of family court in order to become a larger part of my child's life.

A lot of things have changed in our society: men used to be the primary providers and women stayed home to watch the kids. As we all know, this is not the case anymore. Today there are many potential situations: Fathers and Mothers, just a Mother, just a Father, Mothers and Mothers or Fathers and Fathers. We are a state that celebrates and encourages diversity. Most importantly, we consider all people to be equal. We need to bring that equality now to both loving fit parents who long to be with their children. One parent is not better than another. One gender is not better than another. To suggest anything else is backward and has no place in this state.

Please give both parents and most importantly our children, the presumption of 50/50 shared parenting now!
