The meeting was called to order at 1:32PM by Chairperson, Sen. Flexer M. S29.

Members of the Task Force asked questions and made comments.

Jeremy Visone presented in support of the task force and shared his wife Kerry's personal experiences with sexual abuse.

Members of the Task Force asked questions and made comments regarding Mr. Visone's testimony on his wife's behalf.

Laurie Guay gave a presentation in support of eliminating the statute of limitations regarding sexual abuse.

Members of the Task Force asked questions and made comments regarding Ms. Guay's testimony. Senator Flexer commented that Ms. Guay's testimony highlights the amount of work that still needs to be done.

A five-minute recess was given.

The next presentation was given via video conference by Cary Silverman, Member, American Tort Reform Association, gave a presentation on the importance of statute of limitations. The concern is that eliminating the statute of limitations sets a precedent for the future of other types of claims.

Members asked questions and commented on Cary Silverman's presentation regarding his position on eliminating the statutes of limitations and his experience with tort, other legal areas and the American Tort Reform Association.

Chairwoman Flexer announced that the next meeting would be held on January 7 at 1:00pm in Hearing Room 2B.
