Two specific recommendations: 1) a broader pool of candidates and 2) if not able to be done immediately, then the subcommittee recommends changing the implementation date until April 1, 2021.

 - *ii. Question: how should we submit the recommendation, if agreed upon by members?*

 - i. Short term: decertification, liability insurance, qualified immunity sections of the bill. Meeting every other Tuesday at 5pm. Working with CBA task force in forming recommendations. Question: does liability insurance exist elsewhere? A: the subcommittee is looking into this.
