#### III. Presentation: November Young Adult Listening Sessions reports

Joyce Wong – Everyday Democracy, presented on the two reports from the a. November listening sessions. A discussion among participants ensued following the presentation. Tamara Lanier highlighted the issue of diversity in law enforcement hiring, and the various screening guidelines required of applicants (credit scores, employment history, endurance tests) that present as obstacles to people of color becoming law enforcement officers. Maureen Lopes identified the issue raised regarding the history of law enforcement as a necessary component to community education. Steve Hernandez also mentioned the barriers to entering professional life that have historically been rooted in community demand, and therefore it is necessary to understand current community demand as we seek to address different standards for entering law enforcement today. The community must take more responsibility in being the source for the disparate outcomes we hope to change. Chair McGraw then asked Andrew Clark to lead the meeting. Mr. Clark shared his screen and highlighted two PTATF charges on the ctpolicetransparency.com site that address strategies to increase recruitment, retention and promotion of both minority and female officers. He also mentioned that the Task Force will hear
