- ii. Civilian Review Board Recommendation/ Civilian Review Board Requirement Subcommittee asks that we include these in the final report. Recommendation includes different guidelines for each municipality to consider. Subcommittee recommends that all communities with police department should have a CRB.
- iii. Internal Affairs Pre-Service and In-Service Training Recommendation This recommendation is regardless of rank assigned, a uniform training must exist to ensure internal affairs officers throughout the state have similar training. POST Council to determine content, curriculum, hours. Chief Mello questioned why preservice is included. Chief Mello commented that private vendors do a great job of providing in-service trainings. Renee LaMark Muir responded that pre-service indicates a new assignment within the department to conduct internal affairs investigations, not academy recruits. Renee also noted that POST approves private vendors, and should have approval. Brian Foley questioned if pre-service includes various experts/leads, or anyone that will assist. Renee responded no, because they wouldn't be the lead investigator.
