- I. Convene meeting and welcome a. Chair McGraw convened the meeting at 1:04 pm.
- **II.** Review and acceptance of minutes from the 7/13/21 meeting *a. Minutes from the 7/13/21 meeting were approved via voice note.*
- **III.** Old Business
 - a. Primary and Secondary Stop Proposal

Chair McGraw opened the floor for questions on this proposal. Chief Mello commented his concern on the taillight/stoplight section of the proposal. Ken Barone commented that they did voice these concerns in the last logistics subcommittee meeting, ultimately keeping the proposal as it was. Ken Barone also commented that the proposal only applies when one of brake light is out and most cars have three. Marc Pelka asked what the process would be in a secondary offense. Ken Barone responded there would be no action taken; a police officer would not stop that vehicle unless there was a primary offense. Shafiq Abdussabur commented that these laws have not been addressed since pre-1965, the goal is to look at these laws and update them, and reduces unnecessary officer interaction with marginalized communities. Chief Mello questioned why the subcommittee hasn't included unregistered vehicles. Ken Barone responded that the subcommittee looked at other violations, and this proposal expands the window by which an operator driving a vehicle with expired registration from 30 day to 60 days. During that time, the violation would be a secondary offense.

reduce contact between police and the public there will be an impact on crimes solved and prevented. Shafiq commented that some of the reform laws have already impacted how police engage with communities. Chair McGraw commented that interactions are varied. Marc Pelka questioned about what other states are doing in this area and Ken Barone provided some comments about efforts by other states. Chair McGraw requested a roll call vote. 6 yes, 0 no, 0 abstentions, 4 members absent. The motion passed.
