I Alan C. Hall is willing and honestly submitting my testimony about my past and current treatment conditions that hasn't been addressed thus far as of this 1/21/26.

I had a major back operation on my T-11 and 12, plus L-2-thru-5, having them decompressed after falling in the Unit J-2 shower that the shower mat gave way under me as I was washing my left foot.

A month before I was taken to Hartford's Saint Francis Hospital because of my right leg giving out on me while walking the Unit J-2. After my operator in 2023, I placed a Request for Reasonable Accommodations in was denied by Disability Rights Coordinator, Compliance Colleen Gallagher. Once again I have submitted the needed paperwork to receive the Green Form Core Mattress that will help with my current on going medical issues such as not being able to sleep on my right side because of the damage done to my T-11&12 that caused that lost of total usage of three of my fingers on my right hand.

I am currently waiting for the answer for the appeal that I submitted 1/5/26 requesting the Green Fore Core Mattress or an Additional Mattress to relieve ~~my~~ ~~of the~~ ~~of~~ the on-going pain that I have been dealing with since 2023 because of my L-4&5.

So this is just one medical issue the I am having that isn't being taken serious that is leading towards a greater issue to become. My provider doesn't even answer my request and the Informal Resolution System is a joke.

This is just one of the conditions at Macdougall C.I. that needs to be addressed at this meeting, and here is the number of other that alot of men is afraid to step fourth and place ~~THE~~ paper because of being transferred or retaliated against by that staff member or the administration.

- 1)-The Reference Library don't have any up-dated legal material to help with the inmate's case.
- 2)-The Commissary prices has just changed again with higher prices, but the inmates pay has stayed the same and has changed three times since the inmates increase back in 2024.
- 3)-The F.O.I. Officer doesn't respond on no one's timely manner.
- 4)-There is mold in the Unit's over the prison from the ceiling leaking for years and missing tiles and the unit's ventilation system covers and ceiling are very dirty and it is the Facilities Maintenance Dept. to clean it quarterly, but leaves it up to the unit tierman to come the maintenance dept. to get a rolling vacuum machine to do their job and is done half ass.
