The prison is seriously flawed due to operation of it and its not being addressed. Every since it was mandated that inmates get more time out of the cell, the staff here devised a plan to call out of work 90% of the summer of 2025 every weekend. Its one of the only times our families can visit.

The facility has a draft system and should never be short staffed. The inmates have to pay being on lockdown.

Medical needs a overhaul, some staff gets an attitude when you want to address your issues. The medical staff is given immunity with no accountability for their actions. we are forced to go to uconn hospital and given the option if you need a surgery to sign that they are not liable for any damage they may do or you can not be treated. I myself am left with lifetime damage. Inmates are sometimes worse off than when you go in, they practice on inmates. I requested a different hospital due the problems I had before there.

CONNECTICUT PRISON SYSTEM IS LIVING IN THE DINOSAUR AGES. CONNECTICUT NEEDS TO ADOPT AN ELDERLY PAROLE FOR INMATES 60 YEARS OR OLDER. SOME OF THOSE WHO ARE NO LONGER A THREAT TO ANYONE.

THE AMOUNT OF TAXPAYERS MONEY SPENT ON THE ELDERLY IS THROUGH THE ROOF. OTHER STATES HAVE ADOPTED THIS RELIEF. AN INMATE'S RELEASE SHOULD BE TAKEN OUT OF PAROLE'S HANDS, IT SHOULD BE BASED ON A POINT SYSTEM IF AN INMATE HAS STAYED OUT OF TROUBLE AND COMPLIED WITH THEIR PROGRAMING THEN SHOULD BE RELEASED.

CORRECTIONS SHOULD STOP FORCING INMATES INTO A CELL WHERE HE WILL BE ASSAULTED. IF ANOTHER INMATE DOES NOT WANT YOU IN HIS CELL YOU SHOULD BE PUNISHED. SUPERVISORS SHOULD BE HELD ACCOUNTABLE, THEY SAY YOU ARE REFUSING HOUSING. MOST RECENTLY THERE HAS BEEN A FEW DEATHS BECAUSE OF IT.

THIS 85% NEEDS TO BE CHANGED BACK TO THE LAST LAW I BELIEVE IT WAS 65% AND YOU EARNED 10 DAYS A MONTH GOOD TIME FOR GOOD BEHAVIOR RETROACTIVE.

THE BIGGEST PROBLEM OF ALL, NOBODY IS LISTENING TO US.
