My name is Jason Goodz, prisoner no. 228240; a prisoner who has been confined to the state's correctional system since I was a juvenile; that is since 1994 and am thought to be one of the most litigious prisoners today in the system. If I am, then there is good for. Therefore, I submit the following personal testimonies

Testimony A: In sufficient leisure and/or inadequate passive recreation.

This deprivation primarily pertains to the substantial lack of television stations or cable services. The Connecticut Department of Corrections squanders an astronomical dollar amount on cable services, see enclosed document no. 1, for its facilities, particularly Corrigan CC. Despite the massive dollar amount, it is reasonably inferred that the facility misuses these funds by not issuing or allowing all the television channels paid for in this subscription package. See document no. 2 which is an inmate grievance on the matter. Out of all this money spent — probably at the expense of Connecticut

Testimony C : Insufficient food portions and Imbalanced diet.

For over the last three consecutive decades I and other have been subjected to meager food portions that are more appropriate for an adolescent I am 6'2 in height and have dropped to a weight of 169 in 2017 due to food inadequacy. It should noted that I have no co-existing health issues that would affect a weight decline like that.

Moreover, our daily diet consist mainly of carbs with very little protein and virtually no fiber in any of the meals. It is believed that such an imbalanced diet can cause diabetes, which a great deal of inmates have in Connecticut.

There are many other issues that need to be addressed but, I will limit it to the foregoing as to not take up time.
