IM CURRENTLY INCARCERATED AT THE CHESHIRE CORRECTIONAL INSTITUTION. MY TESTIMONY IS ABOUT HOW THE A.D.A COORDINATOR (BLACKSTOCK) REFUSES TO RESPOND TO MY REQUEST AND REASONABLE ACCOMMODATION FORM. I WROTE HIM 11/13/25 AND SUBMITTED A REASONABLE ACCOMMODATION FORM 11/21/25. IT'S NOW 1/20/26 AND HE HAS YET TO RESPOND TO MY REASONABLE ACCOMMODATION FORM WHICH UNDER THE (A.D 10.19) THE ADA COORDINATOR HAS (5) DAYS OR LESS TO RESPOND. I HAVE A HEALTH ISSUE THAT QUALIFY ME TO HAVE ACCESS TO THE A.D.A PROGRAM. (DISABILITY).

I WAS SENT TO UCONN FOR PHYSICAL THERAPY. AND THE RECOMMENDATION FROM THE DOCTOR (SPECIALIST) WAS THAT I RECEIVE PHYSICAL THERAPY, A MATTRESS (MEDICAL), PILLOW, AND ACCESS TO THE WELLNESS PROGRAM (A PROGRAM PROVIDED BY THE ADA).

I'VE FOLLOWED THE CHAIN OF COMMAND AND NO ONE HAS DONE ANYTHING. THIS FORCED ME

TO WRITE A GRIEVANCE. WHICH WAS DENIED BY WARDEN REIS STATING I DIDNT TALK (VERBALLY) TO RESOLVE THE ISSUE. THAT VIOLATES MY RIGHTS UNDER H.I.P.P.A TO DISCLOSE MY MEDICAL CONDITION TO JUST ANYONE. AND I WROTE REQUEST FORMS AND SUBMITTED COPIES OF THOSE AND A COPY OF MY REASONABLE ACCOMMODATION FORMS TO WARDEN SAGEY, COMMISSIONER QUIROS, AND ADA COORDINATOR BLACKSTOCK.

I HAVE COPIES AND DOCUMENTED DATES TO PROVE IT. IM ALSO AWARE OF OTHER INMATES WHO ARE HAVING THE SAME PROBLEM. A.D.A COORDINATOR BLACKSTOCK REFUSES TO DO HIS JOB. HE TOLD ONE OF HIS CO-WORKERS THAT HE DIDNT EVEN WANT THE POSITION.

IM WRITING YOU TO INFORM YOU OF THE CORRUPTION IN CHESHIRE C.I ANYTHING THAT'S GEARED TOWARDS HELPING INMATES THEY PUSH BACK. BUT IF ITS ABOUT WRITING TICKETS OR PUTTING SOMEONE IN R.H.U THEIR ALL FOR IT.

IM WRITING YOU AND MY FAMILY WILL BE EMAILING YOU TO SEE IF YOU RECEIVED MY TESTIMONY. THERE'S ALOT OF CORRUPTION GOING ON IN CHESHIRE C.I AND I FEAR RETALIATION FOR WRITING YOU. SO IF SOMETHING HAPPEN TO ME YOU KNOW WHY.
