WOULD LIKE TO FIRST THANK YOU FOR GWIN' US A FORUM TO LET YA'LL KNOW WHAT'S "REALLY" GOING ON BEHIND THESE WALLS.

I AM IN A "SO-CALLED" HONOR DORM THAT REALLY IS IN A BASEMENT AND ALL THAT ARE IN THIS DORM ARE PRETTY MUCH OVER 50 YRS OF AGE, WHICH HOUSES 33 W-MATES AND HAS A DAYROOM THAT IS CONNECTED TO THE DOG PROGRAM FOR VETERANS, WHICH HOUSES 23 W-MATES.

OUR BATHROOM CONSIST OF 6 URINALS, 6 SINKS & 3 TOILETS. SINCE 10.7.25 TWO OF THE URINALS HAVE NOT BEEN IN OPERATING ORDER, THE LAST URINAL WENT OUT (NOT IN OPERATING ORDER) 10.14.25 AND RIGHT NOW UP TO 1.26.26 ARE NOT IN ORDER. THE 6 SINKS WE HAVE 2 FULLY FUNCTIONAL SINKS SINCE 1.13.26 AND UP TO RIGHT NOW NOT IN ORDER. THE 3 TOILETS HAVE NOT BEEN IN OPERATING ORDER SINCE 1.14.26, WE HAVE TO WALK TO THE DOG PROGRAM TO USE THE BATHROOM AND THEY HAVE 23 W-MATES HOUSED. SO IN TOTAL YOU HAVE 56 W-MATES USING 1 FULLY OPERATING TOILET, 33 USING 2 FULLY FUNCTIONAL SINKS. UNTIL JUST RECENTLY, THE FRONT DORM (HOUSED 33 W-MATES) HAD A STEADY WATER RUNNING OUT OF THE WALL FROM UPSTAIRS (J-1) OF FECAL OR SEWER WATER, IN WHICH HAD TO BE MOPPED UP EVERY HOUR - 2 HOURS, THEN HAVE

A GREAT NUMBER OF TOWELS PLACED AT THE BASE OF THE WALL SO WATER WOULDN'T COME ON THE DORM FLOOR, THAT WAS FINALLY REPAIRED ON 1.20.26 - IT TOOK THEM MANY MONTHS TO GET AROUND TO IT, THEY REALLY (THE PLUMBERS) TREATED IT AS A NOISANCE. AS OF RIGHT NOW THE PLUMBERS HALF-HEARTEDLY MADE A EFFORT TO REPAIR THE TOILETS THAT ARE STILL UN-REPAIRED ON 1.21.26, HE WAS ASKED ABOUT THE URINALS, HE LAUGHED AND RESPONDED, "WHAT ABOUT THEM" THEY'VE BEEN BROKE FOR SO LONG THAT HIS ATTITUDE IS LIKE WE DON'T NEED THEM REPAIRED.

IT'S ALSO LIKE TO NOTE THAT THE DAY THAT THE LEAKY WALL WAS REPAIRED THAT THE WALL, PART OF THE WALL, MADE SO MUCH DUST THAT EVERYONE IN THE DORM WAS GIVEN NEW SHEETS + BLANKETS, THAT AREA WE LIVE IN IS SO OLD THAT I WOULDN'T BE SURPRISED IF IT WAS INFESTED WITH LEAD + ASBESTOS.


