• Go through two recommendations made to larger council for potential action:

- 1. Relative to procedure for defendants to find a way to get treatment as part of a disposition of Family Violence case approved through standards process
 - Had meeting with CSA with Gail Hardy, discussed that this would be housed with the prosecutors as opposed to judicial responsibility, this makes the most sense
 - Joe and Gail have recently met with CSA to discuss this and talk about what this could look like given their experiences,
 - Treatment and foundation of the treatment should be clearly spelled out, no confusion to responsibility and level of understanding and intervention
 - Gail reiterated history of intention with where favorable outcome is received
 - Cases not appropriate for FRO, but are not on track for prosecution
 - Concern about the limited number of programs available to defendants (based on geographical locations, etc.)
 - If completion of program is basis for favorable action, if program has been approved by FRO, CCADV, and committee
- 2. Pretrial SDP
 - $\circ\;$ Liza Andrews sent updated version of statute to Senator Flexor, not recent update on this
 - Concerns where address as it pertains to the language
 - Updated language of SDP statute to be shared when possible?
