JJ SYSTEM DATA OVERVIEW

Court Intake



Case intake is down 20 percent over the past five years, even after Raise the Age The number of unique juveniles referred to the court is down 18 percent since 2007

Court Intake – 16 Year Olds



Detention Admissions



Detention admissions are lower than 2007

Detention Daily Population



Average daily population is down 14 percent due in part to greater investment in community-based alternatives

Wait Time for Riverview



There has been an 82 percent reduction since 2003 in the number of days in detention while waiting for Riverview Placement

Wait Time for Placement



There has been a 10 percent reduction since 2001 in the number of days in detention while waiting for Residential Placement

STRATEGIES AIMED AT RISK REDUCTION

System Improvement

- Juvenile Justice System Improvement Project (JJSIP) from the Center for Juvenile Justice Reform
 - Standardized Program Evaluation Protocol
 - Comprehensive Strategy for Serious, Violent and Chronic Juvenile Offenders

Goal: Further align CSSD Operations and Programs with evidence-based approaches to reduce recidivism

School-based Arrests

- Partner with DCF, SDE, Advocacy Groups, LISTS, local school officials, and researchers to:
 - Identify feeder schools
 - Identify strategies to be utilized at the local level in lieu of arrest
 - Identify funding opportunities

Goal: Improve behavioral interventions and opportunities for diversion at the local level to reduce school-based arrests

Cross-over Youth Project

- In consultation with the Center for Juvenile Justice Reform at the Georgetown University Public Policy Institute (CJJR), a project to address the unique issues presented by children and youth who are known to both the child welfare and juvenile justice systems.
 - Identification of cross-over youth
 - Improving information exchange across systems
 - Family-centered and joint-agency decision making
 - Maximizing services in each system

Goal: A reduction in the number of youth placed in out-of-home care, the use of congregate care, the disproportionate representation of children of color, and the number of youth becoming dually-adjudicated

Disproportionate Minority Contact

- In consultation with the Center for Children's Law and Policy:
 - Develop data reporting capabilities to better identify DMC at all decision points in the JJ System
 - Utilize working groups in Hartford and Bridgeport to develop strategies to reduce DMC

Goal: Increase awareness of DMC at all decision points and collaboratively strategize solutions at the local level
