An Act Concerning the Mental, Emotional and Behavioral Health Of Youths

Progress Report on the Development of a Statewide Children's Behavioral Health Plan

I. Overview

A. Overarching Goal: To meet the behavioral health needs of <u>all</u> children in the state and to prevent or reduce the long-term negative impact on children of mental, emotional, and behavioral health issues.

B. Objectives

1. Plan will be comprehensive in scope

2. Inclusive of system-involved and non-system involved youth

3. Integrated and inclusive of multiple child-serving agencies and systems

C. DCF Governance

 DCF will oversee plan development and implementation
DCF Commissioner to submit plan to Governor and standing committees having cognizance of matters related to children and appropriations

3. Final draft of Plan will be completed in October 2014 with an implementation progress reports on October 1, 2015, and biennially thereafter.

D. Plan Development & Input Gathering

1. Facilitated via DCF subcontract with the Child Health and Development Institute (CHDI)

2. Developed with broad stakeholder input

3. Overseen by Steering Team (DCF, CHDI, Yale University, FAVOR)

4. Informed by an Advisory Committee

E. Overarching Framework

1. Plan will provide an overview of the current system with recommendations for systems integration, change and improvement across the continuum of care

2. Plan will focus on broad spectrum of needed prevention, early intervention, intervention and aftercare that comprise a comprehensive system of care

3. Plan will attend to needs of all children with an emphasis on universal, selected, and indicated approaches to promote healthy development for Connecticut's children
