## I STRONGLY OPPOSE ANY AND ALL LEGISLATION THAT WOULD RESTRICT A PARENT'S RIGHT TO RELIGIOUS VACCINE EXEMPTIONS.

## Reasons to oppose this bill:

- This legislation discriminates against families with sincere religious beliefs. My

- This legislation would discriminate against healthy children and not permit them to attend public school. I would hope that this legislative body is prepared to reimburse families thousands in tax dollars, so that they can attend alternate schools and suffer the financial burden when the willfully employed must quit their job to homeschool their child.
- The current law is working. After the state released a school-by-school vaccine data information many panicked. Yet, despite the inaccurate reporting and the fact that higher rates in some schools only meant they had a smaller population. Many are magnet schools and special education schools. The Connecticut vaccination rate is still currently at >97.5% when we do the math of the recent information released, we are still way above "herd immunity status." Religious and medical exemptions combined are at only 2.1%, which is on target to the national median of 1.8%. What is the death rate from measles vaccine in the US?

- Fact: Vaccinated individuals can pose a higher risk to public health due to a process known as shedding. - Herd immunity is a myth. 80% of all adults are not caught up to the 72 recommended doses of the vaccines. The last dose of the measles vaccines an adult received was in 1983. Vaccines wear off. No pandemic has occurred. I guess our immune systems are doing the job they were meant to do. And interestingly, a study of

plasma donors shows that the increase in measles virus antibody titers after vaccination lasts a whopping 150 days, while naturally acquired immunity lasts a lifetime. The US Supreme Court recognizes vaccines to be "unavoidably unsafe" and to cause injury and death in some recipients. The US Government has paid out more than \$4 billion to the victims of vaccine injury since 2018, with a maximum award of \$250,000 for death.
