I understand that this is not a public hearing but an informational hearing on the Religious Exemption. I find it interesting that this meeting went around the normal legislative process. This is a total abuse of power.

I want to talk about the herd immunity theory. We can start with the USS Fort McHenry. In December 2018, the Fort McHenry was avoiding port calls for three months after 25 sailors were diagnosed with the mumps. The first case was on December 22 and lasted until mid March in 2019. EVERYONE ON BOARD WAS FULLY VACCINATED. [1]

In March 2019, at the Harvard-Westlake School in Los Angeles, there was a whooping cough outbreak with nearly 90 students contracting the whooping cough. ALL 90 STUDENTS WERE FULLY VACCINATED. [2]

In February 2014, the USS Ardent, a navy minesweeper, was moored in San Diego Ca. Over the course of three days 25 of the 102 crew members sought medical care for influenza. ALL WERE FULLY VACCINATED. [3]

The vaccine rate is higher than herd immunity. We have 75% of the adult population that have not been vaccinated since grade school and 20% of the population are vaccinated. For over 50 years we have not had any major disease outbreaks despite the 75% of adults that are not up-to-date.

I want to make it perfectly clear. The unvaccinated are not a threat! The unvaccinated are being discriminated against. We do not have any epidemics in CT or the United States. There is no measles epidemic. The measles is a manufactured crises and does not affect our state.

Our religious beliefs are protected under the U.S. Constitution. The Constitution only requires a religious belief to be "religious in nature" and "sincerely held". Aborted babies are used in vaccines. There seems to be this theory that only one baby was used in an abortion and the cell line continues to this day; when in fact there were many more! I added an information sheet that is written on the vaccine and manufacturers package inserts. You may not have realized this, but different body parts are used for different purposes. The kidney was harvested for the Rubella vaccine, retinal tissue for the Ebola vaccine and the lung for the MMR. Then we have different ages required for the makeup of these vaccines. 6 weeks, 3 months female, 3 months male, 14 weeks male, 16 weeks. As far as religion goes, I do know that MY GOD would never condone killing babies for any purpose.

I'd like to quote Liz Linehan, "Vaccines, for the most part, are safe and effective", May 3, 2019. "For the most part" shows even she has some reservations on the safety and effectiveness of vaccines.

I have 9 children spanning three decades, the 80's, the 90's and the 2000's. My children of the '80's received very few vaccines. At my sons five year visit the nurse and I were discussing the vaccine insert. She told me there was a 1 in 1000 chance he could get autism. Today? 1 in 40? I continued to faithfully follow the doctors orders until 10 years ago. What changed? Why did I feel that this was not the route for my family to take? Well, my research started when the doctor told us to wait in the waiting room for 10 minutes in case your child has a seizure.

I will end by recommending an amendment to any Religious Exemption legislation stating that the State of CT and any signer of said legislation to be held liable for injury and death to its constituents.
