The goal of ECC/HANH is to provide for the health and safety of our residents. Therefore, we are especially concerned about criminal activity that shows behavior that could harm other tenants or ECC/HANH staff or affect their ability to live safely and peacefully. ECC/HANH will consider the following factors prior to making its decision:

- The seriousness of the case, especially with respect to how it would affect other residents.
- Evidence that the case was dismissed.
- The effects that the denial of admission may have on other members of the family who were not involved in the action or failure.
- The extent of participation or culpability of individual family members, including whether the culpable family member was a minor at the time of the offense or is a person with disabilities, or a victim of domestic violence, dating violence, sexual assault; or stalking.
- The length of time since the violation occurred, the family's recent history and the likelihood of favorable conduct in the future.
- Evidence of the applicant's family participation in or willingness to participate in social service or other appropriate counseling service programs.
