### **V. APPROPRIATIONS**

### **Budgeted Lapses and Agency Holdbacks**

The FY 16 and FY 17 budget includes \$212.6 million in FY 16 and \$217.7 million in FY 17 lapses. The lapses are identified below with a brief explanation.

### FY 16 Budget Allocated Lapses (Holdbacks)

Sections 10, 11, 12, 38 and 41 of PA 15-244 contain provisions that allow the Secretary of the Office of Policy and Management (OPM) to allocate specific lapses to state agencies in the three branches of government (these are typically called holdbacks). The following five lapses are allocated to state agencies via holdbacks by OPM: (1) General Lapse of \$10 million, (2) Statewide Hiring Reduction Lapse of \$35 million, (3) Municipal Opportunities and Regional Efficiencies Program Lapse of \$20 million, of which \$14,797,244 is allocated to the State-Owned Property PILOT and College and Hospital PILOT accounts within OPM, a (4) General Employee Lapse of \$7,110,616, and (5) Overtime Savings Lapse of \$10.5 million.

Section 156 of PA 15-5 JSS contains provisions that allow the Secretary of the Office of Policy and Management (OPM) to allocate a Targeted Savings Lapse of \$12.5 million to state agencies in the three branches of government.
