Funds Carried Forward

In addition to the appropriations included in PA 16-2, MSS, as adjusted by PA 16-3, MSS, numerous provisions are made in other sections of the acts, as well as in existing statute to permit an estimated \$121.9 million of appropriations to be carried forward and made available in FY 17.
