Analysis and Summary of Governor's FFY 17 Low Income Home Energy Assistance Program (LIHEAP) Block Grant Allocation Plan

INTRODUCTION

Pursuant to CGS Section 4-28b, the Governor has submitted for consideration the proposed block grant allocation plan for the 2017 Low Income Home Energy Assistance Program (LIHEAP) Block Grant.

Connecticut utilizes LIHEAP funding to support the Connecticut Energy Assistance Program (CEAP). This program serves households whose incomes fall at or below 60% of the state median income (SMI, \$65,155 for a family of four). The Department of Social Services (DSS) administers the program with the assistance of the Community Action Agencies (CAAs).

The proposed plan assumes FFY 17 available block grant funding of \$80.4 million. Additional funding results in total available funds of \$88.2 million, which is 0.9% below the FFY 16 available amount of \$89.0 million. Funding is anticipated to provide benefits to approximately 100,726 households. The table below outlines the proposed FFY 17 budget:

HIGHLIGHTS

The allocation plan makes several changes in comparison to the FFY 16 allocation plan, including the follow items:

- Establishes two new benefit levels for renters with incomes at 151% of the federal poverty level (FPL) to 60% SMI;
- Increases renter benefit levels by \$20 for individuals with income levels at and below 150% FPL;
- Increases basic benefits for vulnerable households by \$5 (all other benefits are level funded);
- Provides a new set-aside of \$1.0 million for weatherization services through the Department of Energy and Environmental Protection (DEEP);
- Maintains \$1.0 million for furnace repair and replacement (\$500,000 less than the FFY 16 allocation plan to better reflect actual expenditures). Funds will cover the cost to clean, tune, and test deliverable fuel heating systems (previously paid for by Basic Benefit);
- Estimates caseload growth based on FFY 12 FFY 15 (FFY 16 caseload decreased by 9% due to a mild winter and a drop in oil prices).

FEDERAL BUDGET ACTION

Final Congressional action has yet to be taken on FFY 17 appropriations for this grant. The FFY 17 estimated block grant amount is based on the final FFY 16 funding level. This allocation plan includes a contingency plan in the event that funding is more or less than the amount assumed in the proposal.

Funding is provided to Community Action Agencies for enhanced case management services to assist low-income households address their energy needs. Services include risk assessment, counseling, education, and assistance with energy suppliers and vendors.

Supplemental Nutrition Assistance Program (SNAP) Benefit

LIHEAP benefits are available to SNAP recipient households who (1) do not make direct vendor payments for their primary source of heat, (2) have a shelter and/or utility obligation, and (3) pay less than 30% of their gross income toward rent. A \$20.01 LIHEAP SNAP benefit will be paid to these households, which qualifies them for greater SNAP benefits.

Program Dates

The program begins on November 9, 2016 and continues through May 31, 2017 as follows:

November 9	First day for authorization of fuel deliveries (and payment for deliveries can be made by
	the program).
March 15	Deadline for fuel authorization or deliveries.
May 1	Last day a household can apply to establish eligibility for benefits.
	Last day that qualified utility heated households can apply to establish eligibility for
May 15	benefits.
May 31	Last day to submit deliverable fuel bills.
