# Analysis and Summary of Governor's FFY 25 Community Services Block Grant Allocation Plan

#### INTRODUCTION

Pursuant to CGS Section 4-28b, the Governor has submitted for consideration the proposed block grant allocation plan for the Community Services Block Grant (CSBG). The allocation plan is effective beginning October 1, 2024.

### **PROGRAM OVERVIEW**

CSBG funding provides grants to help address the causes of poverty, coordinate governmental and non-governmental programs, and provide emergency services to low-income individuals and families. The Department of Social Services (DSS) administers the program with the assistance of the Community Action Agencies (CAAs). Funding is allocated based on federal requirements and a state agreement with CAAs and Limited Purpose Agencies (LPAs). The allocation formula, revised in the FFY 24 plan, uses a combination of a fixed amount per CAA, the low-income population of the CAA catchment area, and the overall population of the CAA catchment area.<sup>1</sup>

# FFY 25 ALLOCATION PLAN

The proposed plan assumes level federal block grant funding of \$9.1 million. Carry forward funding results in total available funds of \$16.7 million in FFY 25. Expenditures are anticipated at \$10.3 million (0.4% above FFY 24) and include the use of \$1.1 million in carry forward funds to support a one-time funding increase as well the FFY 22 - FFY 24 COLAs, applied to all entities. The table below outlines the proposed FFY 25 budget compared to FFY 24 estimated.

# **PROPOSED CHANGES**

The FFY 25 plan does not include the one-time transition funding provided in FFY 24 to assist the three entities negatively impacted by the change in the base allocation methodology established that year.<sup>2</sup> While the absence of this transition funding primarily impacts the Community Action Agency of New Haven (CAANH), this is partially offset by COLA and one-time FFY 25 funding.

The table below details the components of the FFY 25 proposed grants to entities.

# FEDERAL BUDGET ACTION

Final Congressional action has yet to be taken on FFY 25 appropriations for this grant. The allocation plan assumes level funding.

# **CONTINGENCY PLAN**

If funding is more or less than the amount assumed in each proposal, program funding and services may be adjusted. Per CGS Section 4-28b, any proposed transfer over \$50,000 to or from any specific allocation or any transfer amount that is 10% of any specific allocation (whichever is less), must be submitted to the speaker and president pro tempore to be approved, modified or rejected by relevant committees.
