Funding is available for transfer from this account due to the following:

• <u>Personal Services</u> - The agency had lower than projected separation costs, delays in hiring for vacant positions, and the early release of sessional staff after certain committees' Joint Favorable deadlines.

Funding is needed for transfer to this account due to the following:

• <u>Other Expenses</u> - The FY 18 - FY 19 biennial budget rolled out lapses to various agency accounts. In the Office of Legislative Management (OLM), funding for the following accounts was eliminated: Equipment, Interim Salary/Caucus Offices, Redistricting, Old State House, Interstate Conference Fund, and the New England Board of Higher Education. OLM utilized funding in its Other Expenses account to pay for the dues, membership and the interstate compact obligations.

Holdbacks and lapses:

PA 17-2, the budget, included a bottom line lapse of \$1 million for the legislative branch. Based on current projections, OLM is on track to meet their portion of the lapse.

• <u>Care4Kids TANF/CCDF</u> - The FY 18 budget provided funding to reopen the Care4Kids program. The program was officially opened on November 1, 2017 and fully open without a wait list as of February 23, 2018.

Funding is needed in this account due to the following:

• <u>Early Head Start-Child Care Partnership</u> - An increase in the number of Early Head Start eligible families participating in the program when Care4Kids enrollment was temporarily closed. The Early Head Start- Child Care Partnership account supports low-income families with infants and toddlers with a focus on comprehensive and continuous services.
