Although the Department of Motor Vehicles (DMV) has indicated seven new positions will be needed for the proposed changes to sections 14-227a-19a through 14-227a-27a it is anticipated that DMV will be able to handle the first year case load without additional staff. It is anticipated that the increased case load in the second year would result in one new processing technician to handle the administrative requirements for DMV.

The revenue impact of the proposed change to section 14-227a-11a is estimated to be \$112,000 in the first year and \$448,000 in the second year as indicated by the Department of Motor Vehicles,
