The regulations could result in a minimal cost to other state agencies or municipalities, associated with inspecting, updating or closing underwater storage tanks. The costs could range from \$450 to over \$10,000 depending on the tank. However, it is anticipated that these costs could be occurred in the outyears and will offset larger costs associated with repair, remediation, and possible property damage related to outdated tanks.
