**Items #4 & #11** Department of Energy and Environmental Protection: Dam repairs (total of \$1,150,000 in General Obligation bonds)

These funds will be used to finance the design of repairs to the following state-owned dams that are deemed to be high or significant hazard:

- 1. Connecticut Valley Hospital Dams, Middlefield;
- 2. Slater Mill Pond and City Pond Dams, Griswold;
- 3. North Farms Dam, Wallingford;
- 4. Waterbury Levee, Waterbury;
- 5. Bashan Lake Dam, East Haddam;
- 6. Savin Lake Dam, Lebanon; and
- 7. Other dams, as necessary.

#### Background

There are currently 92 state-owned dams that are classified as high or significant hazard. In order to be classified as significant or high hazard, failure of a dam would result in any one of the following:

- 2. How are the dams chosen for repair?
- 3. What is the estimated cost of actually repairing these dams?
- 4. What is the estimated cost of repairing all 92 of the high or significant hazard dams in the state?

**Item #6** Department of Economic and Community Development: Regional Brownfield Development Program (\$10,000,000 in General Obligation bonds)

The Regional Brownfield Redevelopment Loan Fund provides applicants with lowinterest loans to remediate property for economic development projects or to construct housing for first-time home buyers. The loans can be made for manufacturing, retail, residential or mixed-use developments, expansions or reuses.

- 1. Will any of the loans made under this program be forgiven? If so, what would the threshold be for loan forgiveness?
- 2. What are the eligibility criteria for the program?
- 3. Does DECD give preference to economic development or housing projects?

**Item #7** Department of Transportation: Dredging projects (\$750,000 in General Obligation Bonds)

The funds will be used to cover the cost of dredging approximately 50,000 cubic yards of predominantly sandy material from the Housatonic River in four areas south of the Route 1 bridge. The Army Corps of Engineers has agreed to schedule use of its own hopper dredge during the upcoming dredging season, which begins around October 1, 2012. The daily cost to operate the dredge is approximately \$22,000 and the project is expected to take 35 construction days.

The river was last dredged was in 1976, when 215,000 cubic yards of material was removed.

**Item #10** Department of Emergency Management and Public Protection: Upgrades to the state-wide telecommunications system (\$1,401,873 in General Obligation Bonds)

The funds will be used to replace the aging radio tower site currently located in East Haddam, including replacement of the tower, installation of new telecommunications equipment, and construction of an on-site shelter. The tower is currently used by the Department of Transportation and the upgrade will increase coverage along the Connecticut River and provide radio-system access to the Department of Emergency Services and Public Protection, the Department of Energy and Environmental Protection, the Department of Motor Vehicles, and the Department of Correction. The on-site shelter will hold radio equipment for state agencies and municipal entities.

**Item #16** Department of Energy and Environmental Protection: Flood control projects (\$429,000 in General Obligation bonds)

The funds will be used to finance the design of Phase II of the South Branch Park River flood control project in Hartford, which is supervised by the Natural Resources Conservation Service's Emergency Watershed Protection (EWP) Program.

Phase I of the South Branch Park River flood control project in Hartford opened in 2008. It included a multi-use greenways trail that runs from Flatbush Avenue to Nilan Street that is 1,690 ft long, 12 ft wide. There are trail-head plazas located at each end and it is lined with steel benches, trees and shrubs. Phase II will construct the next section of trail from Nilan Street to Newfield Avenue. Future project phases will extend it along Brookfield Street, from Hamilton Street to Flatbush Avenue. Ultimately, the trail could connect with trails that are planned for Pope Park, West Hartford and Newington.

**Item #25** Department of Economic and Community Development: Housing Trust Fund (\$15,000,000 in General Obligation bonds)

The Housing Trust Fund Program provides competitive loans and/or grants annually to eligible developers for the development and/or preservation of housing for low- and moderate-income families and persons at affordable prices.

**Item #27** Department of Economic and Community Development: Manufacturing Assistance Act (\$8,730,000 in General Obligation bonds)

These funds will support the following business initiatives:

**LifeCare, Inc. - Shelton (\$1,800,000)**: The funds will provide a loan for leasehold improvements and equipment related to the expansion of operations. The company intends to retain 157 jobs and create approximately 200 jobs over the next three years.

#### Explanation of Benefits

DECD will provide a 10-year loan at 2.0% with principal deferred for two years. A portion of the loan principal will be forgiven based on job creation levels: (1) 100 jobs will result in \$250,000 being forgiven; (2) 151 to 200 jobs will result in up to \$750,000 being forgiven; and (3) over 200 will result in an additional loan forgiven of \$4,500 per job, not to exceed the outstanding loan principal.

LifeCare helps employers reduce absenteeism and improve employee satisfaction. It intends to change its current telephone-based method of communicating with clients and their employees to an Internet site.

**B. FactSet Research Systems, Inc. – Norwalk (\$2,000,000)**: The funds will provide a loan for renovations and improvements to FactSet's headquarters in Norwalk. The company intends to retain 641 jobs to create 200 jobs over the next five years.

#### *Explanation of Benefits*

DECD will provide a 10-year loan at 2.5% with principal deferred for five years. The loan may be forgivable if FactSet reaches its job creation and job retention goals.

In addition to this loan, FactSet may also be eligible for job expansion tax credits and up to \$8.0 million in Urban and Industrial Sites Reinvestment Tax Credits.

FactSet Research Systems, Inc. is a financial data and software company that provides investment professionals with access to financial data.

**C. Beacon Industries – Newington (\$1,500,000)**: The funds will provide a loan for the acquisition of TECT Power in Newington and consolidation of the operations in TECT Power's facility. Beacon Industries intends to retain 162 jobs and create 60 jobs within six years.

#### Explanation of Benefits

DECD will provide a 10-year loan at 4.0% with principal deferred for five years. Up to \$250,000 of the loan may be forgiven if the company meets its jobs goals.

In addition to the loan, the Connecticut Development Authority also provided a \$1.5 million loan to the company.

Beacon Industries and TECT Power are suppliers of precision aerospace machining, components, and parts. Beacon plans to invest \$10.2 million in relocating and consolidating the operations to TECT's facility.

**D. Peter Paul Electronics Co., Inc. – New Britain (\$2,750,000)**: The funds will provide: (1) a \$2.5 million loan for the relocation of the coil operations that are currently located in Puerto Rico; the purchase of machinery and equipment; and facility improvements and (2) a \$250,000 job training grant. The company intends to retain 125 jobs and create up to 75 jobs within five years.

#### Explanation of Benefits

DECD will provide a 10-year loan at 2.0% with principal and interest deferred for one year. If the company reaches its job goals within five years, \$1.5 million of the loan will be forgiven.

Peter Paul Electronics manufactures solenoid valves for the energy, medical, bio-tech, automotive, construction, infrastructure, and agriculture industries.

**E. Town of Groton for U.S. Navy Submarine Base (\$455,000)**: The funds will provide a grant-in-aid to Groton for the acquisition of a parcel adjacent to the Naval Base. The purchase will prevent development of the land that could encroach on the base's operations. The goal is to enhance the military value of the facility.

**F. Town of Ledyard for U.S. Navy Submarine Base (\$225,000)**: The funds will provide a grant-in-aid to Ledyard for acquisition of a parcel adjacent to the Naval Base. The purchase will prevent development of the land that could encroach on the base's operations. The goal is to enhance the military value of the facility.

### Question:

- 1. Is there any indication that the Naval Base is on the list of potential closures?
- 2. What other measures could be taken to further improve military value of the base?

**Item #28** Department of Energy and Environmental Protection: Repairs at Fort Trumbull State Park (\$492,202 in General Obligation bonds)

These funds will be used to make repairs to Fort Trumbull State Park in New London (masonry repointing<sup>2</sup> and repairs to the visitor center) and Fort Griswold State Park in Groton (masonry repointing, museum roof repairs, and basement waterproofing).

<sup>&</sup>lt;sup>2</sup> Repointing is the process of renewing the external part of mortar joints in masonry construction. Over time, weathering and decay cause voids in the joints between bricks that allows the entrance of water, which can cause significant damage through frost weathering.

**Fort Trumbull** was built between 1839 and 1852. It is one of a group of 42 forts that were constructed for the defense of the United States coast and harbors. This group became known as the Third System of Fortifications. Fort Trumbull is unique in the "Third System" because of the Egyptian Revival features incorporated into its architectural design.
