# II. Agenda Items

Item #1 & 9 Office of Policy and Management: IT Capital Investment Program (\$26,051,835 combined in new GO bonds)

This funding will be used to develop and implement information technology enhancements for the Department of Emergency Services and Public Protection (DESPP), the Department of Administrative Services (DAS), and the Office of the State Comptroller (OSC).

Funding will be used for the following projects:

- **DESPP-** Combining outdated Automatic Fingerprint Identification System with upgraded Computerized Criminal History system.
- **DAS-** Contract with IT consultants for phase one of initiatives to help DAS centralize human resources functions and develop a state-wide one-stop portal for individuals starting a business, accessing support during a family crisis, or seeking stability through training and employment.
- **OSC-** Continued upgrades to the CORE CT Statewide Financial System

**Item #2** Department of Emergency Services and Public Protection (DESPP): Criminal Justice Information System (\$8,900,000 in new GO bonds)

The Criminal Justice Information System (CJIS) is tasked with the development and implementation of the Criminal Information Sharing System (CISS), the technology used to immediately and effectively share law enforcement data across all state law enforcement and criminal justice agencies. Requested funds will be used by the CJIS governing board to or ongoing costs associated with improving the system. To date, approximately \$61 million in allocations have been dedicated to CISS.

Item #3 Office of Policy and Management: Grants for Public Health Concerns (\$5,000,000 in new GO bonds)

Funds will be used as part of the state's efforts toward mitigating the COVID19 pandemic. Specific use of the funds will be controlled by the administration through the allotment process.

**Items #4, 6 (sec. 40(a)(10)) & 7:** Municipal Grants (\$106,000,000 in new GO bonds; \$30,000,000 in new Special Tax Obligation (STO) bonds)

**Town Aid Road** is a statutory formula grant distributed to municipalities based on the amount of paved and unpaved road mileage in each town. Towns may use this funding for highway and bridge construction, improvement or maintenance, snow plowing, tree trimming and removal, installation and maintenance of traffic signs and signals, and for other traffic safety, planning, and administrative purposes. \$30 million is funded via GO bonds, with another \$30 million via transportation bonds. (\$60,000,000 total)

**Grants for Municipal Projects** is a grant distributed partially based on the amount of tax-exempt manufacturing machinery and equipment in each town, and partially based on each town's property and income wealth. These grants can be used for the same purposes as Town Aid Road grants. PA 20-1, the FY 20 and FY 21 bond bill, increases the authorization for these grants by \$16 million over FY 19 levels. (\$76,000,000 total)

See Appendix for the estimated FY 20 distribution of these grants.

Item #5 Connecticut Port Authority: Deep Water Ports, including Dredging (\$30,000,000 in new GO bonds)

These funds will be used to provide supplemental financing for redevelopment and upgrades to the State Pier in New London in accordance with the Harbor Development Agreement. This is a public-private partnership between the Port Authority, North East Offshore, LLC and Gateway New London, LLC. This funding is part of the overall \$157 million deal announced by the administration in February 2020.<sup>1</sup>

Items #6, 22, & 23 Department of Transportation: Infrastructure Program (\$232,722,039 in new STO bonds)

These funds will be used to finance several programs under the Department of Transportation's (DOT) Infrastructure Program. The Town Aid Road grants can be found under Item #4. Below is a break out of the funding for each program.

#### Bus and Rail

Funds requested as part of item 6, along with items 22 and 23, will be used to fund various bus and rail facilities, and equipment, including rights-of-way, other property acquisition and related projects. **(\$156,800,000 total)** 

#### Item #7 – See Item #4

Items #8 & 18: Judicial Department: Security Improvements at Various Courthouses (\$2,090,200 in new GO Bonds)

A security assessment is underway at six urban courthouses, which will result in physical modifications and security upgrades. The six courthouses are: GA 2 Bridgeport, Fairfield JD, GA 23 New Haven, New Haven JD, GA 14 Hartford and GA 4 Waterbury. Funding will be used for security improvements at all courthouse locations including enhancements, modifications, additions and replacement of weapons detection equipment, video surveillance equipment, alarm monitoring and cellblock locking control systems, access control equipment and sallyport doors at courthouses statewide.

#### Item #9 – See Item #1

Items #10 Judicial Department: Alterations, Renovations and Improvements (\$750,000 in new GO Bonds)

Funding will be used to finance a planning study for potential development of a new courthouse to replace aging and obsolete existing facilities in Bridgeport (Main Street - 1970 and 172 Golden Hill Street - 1888) and New Haven (121 Elm Street - 1914 and 235 Church Street - 1968). The planning study will help guide the state in the best course of action to modernize courthouse facilities.

Items #11 & 12 Department of Transportation: Infrastructure Program (\$82,733,116 combined in new STO bonds)

These funds will be used to fund various Infrastructure Program items, as detailed below. The \$22.3 million for the Fix-it-First Road Program will provide rehabilitation and reconstruction of roadways on the state highway system. The projects for the state bridge program are included under item #6.

Item #13 Office of Policy and Management (OPM): Body Worn Camera Program (\$146,653 in new GO bonds)

The requested funding will be used to reimburse the Norwich Police Department for the purchasing of body worn cameras. To date, there has been approximately \$6.3 million provided to municipalities for the reimbursement of body-worn camera purchases. During the 2019 legislative session, the program was expanded to include the replacement of dashboard camera devices that were purchased in 2010 or prior.

**Item #14** Department of Veteran's Affairs: Alterations, Renovations and Improvements to Buildings and Grounds (\$250,000 in new GO bonds)

Funding of \$250,000 is requested for the projects listed below.

- Replace three environmental recovery units (\$60,000) in the Health Care Center. These units are required to retain the Skilled Nursing Facility license which the Health Care Center currently has.
- Paving various areas of the Rocky Hill campus (\$80,000). Certain areas require repaving due to trip/fall hazards for pedestrians.
- Fire system repairs (\$30,000) based on independent inspection of fire detection and suppression systems.
- Minor capital repairs (\$80,000) pertaining to the steam, heating, and water systems. The funding will address current leaking steam systems in tunnels along with any other minor capital emergency projects that arise.

**Item #15** Department of Energy and Environmental Protection: Alterations, Renovations and New Construction at State Parks (\$500,000 in new GO bonds)

This allocation will be used to finance minor capital improvements at various state parks and wildlife management areas. It may be used, in conjunction with a \$1 million allocation made at the December 18, 2019 SBC meeting to hire contractors to assist in the removal of damaged or distressed trees on state property, as a result of weather and insect issues.

Items #16 Judicial Department: Technology Strategic Plan Project (\$2.5 million in GO Bonds)

Funding will be used to address to replace an end of life critical disk storage system that will no longer be supported, and to increase the efficiency and response times for applications such as e-filing that is used by the public, and systems that are used to record and disseminate time-sensitive information in criminal justice and juvenile matters.

Item# 17 Department of Transportation: Let's Go, CT! (360,000,000 in new STO bonds)

These funds will be used to finance various transportation projects outlined in the below chart.

**Item #19** Department of Administrative Services: Infrastructure Repairs and Improvements at State-owned Buildings (\$225,000 in new GO bonds)

Funding of \$150,000 will be used for the removal and replacement of the existing carpet at the Department of Developmental Services area located at the Phelps building at the Uncas on the Thames property.

Funding of \$75,000 will be used by the Department of Public Health for a consultant to design, provide contract documents, bidding and construction administration for the replacement of the uninterruptible power supply (UPS) system at the agency laboratory in Rocky Hill. The study will include a comprehensive look at fuel storage tanks, conduit runs to the building, interior space for transfer switches, panels and additional UPS capacity to support the existing 800K emergency generator to service the building to remain operational capacity during an emergency event.

**Item #20** Department of Administrative Services: Infrastructure Repairs and Improvements at State-owned Buildings (\$960,790 in new GO bonds)

Funds will be used to award a construction contract based on bids received on December 11, 2019 for fire alarm system replacement at 505 Hudson Street in Hartford. This project consists of a new fire alarm initiation and signal devices, transponders and associated fire alarm equipment. The ten-story office building contains approximately 153,000 square feet of space above a parking garage. The existing fire alarm system is approximately 30 years old and requires upgrades to comply with current building codes.

**Item #21** Department of Mental Health and Addiction Services: Fire, Safety and Environmental Improvements to Regional Facilities (\$500,000 in new GO bonds)

Funding of \$500,000 is requested to support various emergency and minor capital improvements (which may include electrical and structural repairs) at DMHAS regional facilities, on an as needed basis.

# Items #22 & 23 - See Item #6

Item #24 Department of Housing: Loan to Grant Conversion (\$1,500,000 of reallocated GO bonds)

This request is to convert a loan, made through funds allocated in 2002, to a grant because the Department of Housing (DOH) has been shown that there are no viable assets available to repay the loan. The funds were initially provided for a loan that was used to create a revolving loan fund to support affordable housing projects.

# Background

This reallocation relates to funds approved for DECD, the predecessor of DOH, at the September 27, 2002, State Bond Commission meeting that were used to provide a loan to the Community Development Financial Institution (CDFI) Alliance. CDFI combined the state funds with \$25,000 of private sector funds to establish a revolving loan fund (Sec. 8-218). The revolving loan fund provided loans and grants to local organizations and individuals to finance affordable housing projects. Several of these projects went bad and had their loans forgiven. CDFI was also dissolved and its assets and liabilities were taken on by Capital for Change. There are two loans remaining, but they are delinquent, on interest-only payment plans. Capital for Change is asking for the loan to be forgiven because there are no viable assets available to repay the original loan.

**Item #25** Departments of Energy and Environmental Protection and Public Health: Clean Water Fund (\$31,000,000 in new revenue bonds)

These funds will be used to provide low-interest loans to various municipalities, and/or public water systems, to assist with Clean Water Fund (CWF) project costs. Common uses of the funds include nitrogen control to restore the Long Island Sound, combined sewer overflow abatement, and phosphorus reduction in non-tidal surface waters. The Department of Energy and Environmental Protection (DEEP) will disburse funds to individual CWF projects that have met all statutory and administrative requirements as outlined in the currently adopted DEEP Priority List.<sup>2</sup>

Item #26 Office of Policy and Management: Urban Act (\$6,600,000 in new GO bonds)

I. Department of Economic and Community Development

# A. City of West Haven for the Beach Street Reconstruction Project (\$5,200,000)

The allocation will fund a grant-in-aid to West Haven for Phases II and III of the Beach Street Reconstruction

Project. The project calls for raising a 4,000foot stretch of First Avenue and Beach Street from Monahan Place, near the wastewater treatment plant, to Morse Avenue, near the former Chick's Drive-in restaurant. Elevations will range from 2 to 5 feet, based on existing topography.

Phase I covers the area near the wastewater treatment plant, nearly wiped out during Super Storm Sandy. Improvements under Phases II and III would prevent flooding of homes and allow for economic development of land that once housed Captain's Galley, Chick's Drive-in and the Debonair Motel.<sup>3</sup>

II. State Library

# A. Hartford Public Library Relocation (1,400,000)

This allocation will be used to finance a supplemental grant-in-aid to the Hartford Public Library, for relocation of the Park Branch to the former Lyric Theater site on Park Street (pictured below). The Lyric Theatre was heavily damaged by fire in

the 1970's and has been vacant since.

Plans for the 13,000 square foot project were approved in March, 2019. Construction was originally scheduled to begin in spring 2019, but a ceremonial groundbreaking did not place until summer. Actual take construction began in January, 2020 after delays in site preparation and environmental testing. The library, when completed, will include a 150-seat community room, learning lab, meeting cafe, exhibit rooms, space, and Total courtyard. project cost is anticipated to be \$12.5 million.
