Dear Sen. Harp, Rep. Walker, Sen. Kane, and Rep. Miner:

This is the third quarterly status report for the on-line searchable database required by PA 10-155, subsequent to its going live on 6/29/11. PA 10-155 requires quarterly reports to the Appropriations Committee on its progress beginning 11/1/10 and thereafter. This communication is intended to satisfy the 2/1/12 requirement.

The site, which is located at <u>http://www.transparency.ct.gov</u>, went live June 2011 with the inclusion of Fiscal Year 2010 data. In the Fall of 2011, FY 2011 data was added, so that two fiscal years are now available. A linkage to the site is currently provided via the homepage of the Office of Fiscal Analysis.

Since the site went live, there have been 54,589 visits with 7,219 unique visitors from at least 75 countries; the sources for a majority of these visits have been the U.S. (53% of the total) and China (31% of the total).<sup>1</sup> The most active date thus far remains Friday, July 8th with 631 visits. Active employee compensation has been the most frequently viewed subpage on the site, with nearly three times as many visits as Pensions, which is the next most visited subpage followed by Expenditures, Payments, Contracts and Grants.

In previous quarterly reports we have indicated that data from "limited scope" agencies may be incomplete in CORE-CT, which is the basis for the transparency site. The table below summarizes the impacts these data limitations have on the transparency site.

We are planning to review options to address these data challenges in calendar year 2012, including working with state agencies directly to acquire datasets that conform to the transparency site's data structure, scope and confidentiality. A Memorandum of Understanding is in effect between the Secretary of the Office of Policy and Management and President of the University of Connecticut to increase by July 2013 the use of CORE-CT by the University of Connecticut, including the Health Center. It is anticipated that this change will substantially increase the data currently within CORE-CT and reflected on the transparency site.
