Opening Remarks and Introductions

Report on the Home Health Initiative by Value Options- Dr. Steven Moore and Dr. Laurie Van Der Heide



According to Dr. Moore, this two year study is the only one like it in the country that has been addressing Home Health services actively. This initiative focuses on the enhancement and recovery for individuals to achieve their own potential

which is the guiding principle of the CTBHP. The gold measure of this initiative is/are the outcomes. In 2012, there were 73 Home Health providers in Connecticut. There are three (3) major and three (3) minor service types:

<u>Major</u>	<u>Minor</u>
Skilled Nursing Visits	Speech Therapy
Medication Administration	Occupational Therapy
Home Health Aide Services	Physical Therapy

Home Health Aide Services are measured and divided into units of fifteen (15) minutes of time with four (4) units to an hour.

Discussion

Co-Chair Howard Drescher asked Dr. Moore to sum up the initiative to date. Dr. Moore's comments were that adult Behavioral Health needs to be looked at every level of care in the state. Community providers need to be committed to Home Health services. Relationships between providers and clients need to be looked at carefully and evaluated.
