## **Opening Remarks and Introductions**

Co-Chair Heather Gates convened the meeting at 2:08 PM, welcomed everyone and introductions were then made.

## Presentation of Intensive Outpatient Program (IOP) Review-Bonni Hopkins (Beacon)



Bonni Hopkins gave the report on Intensive Outpatient Treatment (IOP): Evaluation of a Prominent Level of Care within the Connecticut Medicaid Behavioral Health Service System in place of Bert Plant who is out on medical leave. This is a 2015 Study of Intensive Outpatient Programs (IOPs). DSS, DCF, & DMHAS directed Beacon to conduct a study of IOPs during 2015. The study was to include programs serving youth and adults as well as mental health, substance abuse, and co-occurring disorders. This presentation concerns programs serving adults. For the full report see above and it is also published on-line at the BHPOC Website. The committee will review IOP every three to six months.

# Impact of State Budget on Adult BH Services and Access Court Support Services Division (CSSD) - Michael Aiello

With the questions of "What areas in the adult system are ending and what areas should be tracked for input?" Mike Aiello said that every area in CSSD has been cut. Approximately 300 Judicial Branch employees have been laid off. 123 residential treatment beds have been eliminated from the 311. There is a 2.31% cut in funding across the board (ATB) for all adult program models. These reductions and cuts may have an impact on recidivism. Co-Chair Heather Gates commented that the decrease in funding will result in increased Emergency Department visits, more hospitalizations, increased homelessness and incarcerations. Dr. Chuck Herrick commented that money should be spent on providers and services and not for pharmaceuticals.

# Department of Social Services (DSS) - Bill Halsey

Bill Halsey said that BH programs are expected to stay intact but there will be a 15% decrease for medical homecare administration that should net a \$20 million savings.

# Certified Community Behavioral Health Clinics (CCBHCs) Update -DMHAS/DSS/DCF

Both Bill Halsey (DSS) and Colleen Harrington (DMHAS) said that progress is being made in the process of obtaining the federal planning grant for Certified Community Behavioral Health Clinics from SAMHSA/CMS but there is no significant update. Colleen said that a meeting was held the first week of June for providers.
