## **Opening Remarks and Introductions**

Co-Chair Heather Gates convened the meeting at 3:09 PM, welcomed everyone and introductions were then made. She said that the meeting was focusing on reconvening and discussing topics that would be of concern to the best interests of the consumers in the behavioral health system.

## **Outpatient Service Engagement**

Co-Chair Heather Gates commenced the discussion on getting people discharged and getting them connected to services. If they are immediately connected, they may go once or twice but may not continue because they are not engaged in their own treatment. It is critical that no more than 48 hours pass before they seek treatment otherwise, they may not seek treatment. This causes problems because relapse will likely result. For opiate addicts, continuing treatment means keeping them alive. The discussion focused in on what are the obstacles. Same day induction was also talked about then people are more likely to return to treatment for a third, fourth or fifth time. Bill Halsey (DSS) said that patients who are enrolled in Behavioral Health Homes have a better track record of

returning for treatment and medication adherence. Bert Plant (Beacon) conferred that they have a better record staying in connection to treatment. Heather said these are the people with diagnostic severe and persistent depression, schizophrenia. Heather suggested it may be a capacity and not an engagement issue. Bert said that it is important not to forget about alcohol addiction. The Opioid Crisis is getting much more attention these days.
