State Opioid Response (SOR) Grant Initiative, 'How Can We Help You' Program? - Lauren Siembab (DMHAS)

This program gives Medication Assistance Treatment (MAT) access via 17 outpatient clinics for Opioid Use Disorder (OUD). They try to outreach to people who would not normally come/go to a clinic for treatment. They have people who are recovery assistants and first responders that use a MAT van (travels in Bristol, New London, Norwich, the Berlin Turnpike-Newington/Wethersfield/Berlin/Rocky Hill, New Britain, Middletown, and Torrington) that go out and search for and locate individuals who are on opioids and have had a history of overdosing and then connect them with treatment.
