BHP OC Administration

Co-Chair Sharon Langer convened the meeting at 2:05 PM, and members introduced themselves. She welcomed new Council member, Deena Tampi (Appointed by the Governor). Sharon then asked for a motion to accept the September meeting summary. A motion was made by Pat Rehmer and seconded by Eliot Brenner. All members voted to approve the summary as written.



Sharon then notified Council Members about the November 18, 2016 MAPOC meeting where she and Co-Chair Representative Mike Demicco will give a presentation about the Behavioral Health Partnership Oversight Council to MAPOC Members. Then following the agenda, Sharon led the conversation for the Council to focus on health equity this year and the implications for the BHPOC committee structure. Members were asked to pre-read the Beacon report on *Health Equity and Inequity in the Connecticut Medicaid Behavioral Health Service System* that was previously presented to the Council and re-distributed earlier in November before the meeting today. Dr. Bert Plant (Beacon) handed out a summary of the report (see above icon). Sharon asked members for comments and/or questions from members. Bill Halsey (DSS) weighed in on the issue and stated that the State Agencies and Beacon Health Options felt that *health equity*

was important to bring to address in partnership with the BHPOC and the difficulty to tackle in the BH system. Paul Acker thought that the Behavioral Health Homes (BHHs) and other programs were supposed to take care of health equity disparities. He asked if BHHs were working and whether there is data on outcomes. The question was asked, outcomes for whom? Kelly Phenix asked the age old question, are people getting better? Paul said that metrics are good but not very helpful in understanding the reality of what is happening in the BH system. After a discussion of what areas in the report to focus on, members were asked to come to the next meeting prepared to discuss the reorganization of the committees in terms of health equity. Beresford Wilson talked about needs as a human being and not just as a statistic.

Action Items

Judith Meyers made a motion to adopt Health Equity as a focus for the Council. Beresford Wilson seconded. Co-chair Sharon Langer asked for further discussion. A vote was taken, all in favor, without nays or abstentions. Sharon told the Council that the Executive Committee will discuss how to move forward with this new focus on health equity and how it impacts the work and/or title of the committees.

Due to the length of discussion on Health Equity, the NGA presentation was postponed to the December BHPOC meeting.

Connecticut Behavioral Health Partnership Agency Reports: Department of Mental Health and Addiction Services –Colleen Harrington

Colleen Harrington gave an update on the discussion from September about the Court Support Services Division and Department of Corrections elimination of funding for 133 substance abuse treatment beds from the system. She emphasized that access to the beds was not an entitlement; however, a pilot program is going into effect that allows a flexible cap on unused days that can be banked and used to accommodate a need in beds based on average length of stay. (From last meeting: Pat Rehmer (Hartford Healthcare) suggested that the state should consider whether instead of imposing a cap on the number of beds an average census should be employed so as not to lure people away from seeking appropriate substance abuse treatment.) Co-Chair Sharon Langer thanked Pat Rehmer and DMHAS for working this situation out to an acceptable solution.

Department of Social Services-Bill Halsey

Bill Halsey had no report or update to give.

Department of Children and Families – Karen Andersson

Karen Anderson announced that she will be retiring as of January 1, 2017. Beresford Wilson paid tribute to Karen for being both a mentor and friend through his many years of involvement in the system. The Council will honor Karen's contributions to the BHPOC at its December meeting.

BHP Consumer Advisory Council Update

Co-Chair Steve Girelli of the Child/Adolescent Quality, Access & Policy Committee gave a review of the October 13, 2016 joint meeting of the BHPOC Executive Committee Co-Chairs and the BHP Consumer advisory council members. He also thanked BHPOC members who attended. It is the hope of both Councils to educate and inform one another of the issues, events, and developments undertaken by each Council. This update will be a standing agenda item for both Councils and committees of the BHPOC.
