## BHP OC Administration

Co-Chair Sharon Langer convened the meeting at 2:06 PM, asked members to sign the attendance sheet, and the Co-Chairs introduced themselves as did the members. Sharon informed members that the May summary was not ready yet and will be sent out to them soon for their review and voted upon at the July meeting.

Sharon told Members that Dr. Stephney Springer will be soon joining the Council as the new DCF Liaison and in the meanwhile, Dr. Lois Berkowitz has agreed to continue to come to Council meetings. Sharon thanked Lois for her continued support and active partnership with the Council. She also welcomed Alyse Chin who is officially replacing Colleen Harrington as the DMHAS Liaison. Not a new comer to the Council, Alyse has represented the department from time to time. In addition, Sharon announced that Council Member Deena Tampi is moving out of state with her family and has stepped down from the Council. She had been appointed by the Governor to fill a seat reserved for a "general hospital or specialty psychiatric hospital". She asked members to recommend names of people who would be able to fill that opening.

Finally, Sharon announced her own retirement from Connecticut Voices for Children at the end of August and said that her co-chairpersonship will need to be filled from within the Council. Nominations should be sent to Council Administrator David Kaplan by the next meeting date. She talked of the extraordinary honor of being Co-Chair of the Council and participating in the Council since its inception. She stated that it was a privilege to support the work of the members, the Council and more importantly, the work of the Partnership. She was concluded in a round of applause.

## Action Items



Co-Chair Sharon Langer re-introduced the attached revised proposal for a protocol to select Committee Co-Chairs. Terri DiPietro made a motion to accept the proposal and was seconded by Alice Forrester. Hearing no discussion, she called the question to accept the motion. All voted to accept with no abstentions and the motion was unanimously accepted.

# Connecticut Behavioral Health Partnership Agency Reports:

Since there is not final state budget, the agency liaisons (DSS, DMHAS, DCF, and Jud) could not report on the impact of the budget on funding and programs.

**Department of Mental Health and Addiction Services** –Alyse Chin The Project- ECHO (National Project) RFQ deadline is June 16, 2017 at 2:00 PM for responses. Bert Plant (Beacon) said that Beacon will qualify providers with the opportunity to participate in an education and consultation web-based audio video on how to give medication assisted treatment for opioid disorders. Bert said that they are trying to reach out to as many different types of providers that are out in the state.

## Department of Social Services-Bill Halsey

Bill Halsey (DSS) said that Project-ECHO does not address the rate issue, as it is more for peer coaching with the treatment of suboxone and narcan. A discussion ensued on the differential reimbursement rates depending on the type of provider.

### Department of Children and Families – Dr. Lois Berkowitz

## Health Equity Roadmap: Bert Plant (Beacon)

Bert Plant (Beacon) presented a strategy for improving health equity in the BHP by analyzing access to behavioral health clinic services.. For the full description of the "Roadmap", see the

icon above. Co-Chair Sharon Langer introduced the presentation by describing that the BHP is using the health equity lens to improve access and outcomes in the behavioral health system. Bill Halsey (DSS) explained that the agencies started seeing reports that showed disturbing discrepancies in the extent to which different racial/ethnic populations were accessing services. So in 2015, DSS, DCF, and DMHAS directed Beacon to conduct a Health Equity Study. The study found evidence of disparate utilization of behavioral health services across various levels of care when comparing racial and ethnic groups. The goal of the BHP is to ensure that *all people have the right to equal access to care*.

<u>*Health Equity*</u> is defined as the realization of systems and conditions that provide all people with the opportunity to achieve good health through equitable access, quality, and outcomes of health care.

<u>Health Disparities</u> are differences in health care access, quality, or outcomes among distinct segments of the population that are systematic, avoidable, and unjust.
