#### **BHP OC Administration**

Co-Chair Pat Rehmer convened the meeting at 2:03 PM, and introductions were made. She then asked Council Members for a motion to accept the January 2018 summary. Dr. Eliot Brenner made the motion and was seconded by Valerie Wyzykowski. All voted to accept the January summary as written with no nays or abstentions. Next, Pat asked audience members if they had any public comments and there were none.

Pat then raised the next agenda item, the Veyo (new Administrative Service Organization-ASO) Corrective Action Plan for **Non-Medical Emergency Transportation (NEMT)** for Medicaid. This was an outcome of the discussion from last month's Council meeting and other meetings that Veyo had during January, Veyo's first month of operation in Connecticut. Rod Winstead (DSS) shared with Council Members that the Department shares the frustration in the way that Veyo started the initial implementation of the NEMT contract as of January 1, 2018. It was the Department's expectation that from Day One, all of Medicaid members would receive professional, reliable, and timely transportation and the Department is going to continue working with Veyo until all expectations are met. Rod directed Members to the DSS and MAPOC Websites to see the actual working draft of the Veyo Corrective Action Plan (this link had also been sent to BHPOC Members previously to this meeting). It is the Department's opinion that this working draft did not meet the high standards of the Department so the Department is a more adequate and acceptable Correctional Action Plan.

Representative Jonathan Steinberg said that he had a recent meeting with representatives from Veyo and was told that Veyo had passed on current data to DSS and he was wondering when the Department will share that data. Rod said that current data was received, reviewed, and is ready to be shared. Representative Steinberg retorted that "This was a missed opportunity not to share it today with this Council." Co-Chair Pat Rehmer asked if the new current data will be posted to the DSS Website. Rod said that we will check with his administration to see if it could be posted and he will let Representative Steinberg know too. Kelly Phenix asked specifically what kind of data was shared. Rod said it was typical transportation data from the call center and complaint Co-Chair Beresford Wilson said that DSS needs to be accountable to the primary data. benefactors of NEMT services and that is to the families who are utilizing these services. The Department also should consider these families involvement in the process by giving feedback and grading of the contractor. Janine Sullivan-Wiley congratulated DSS on its letter to Veyo on the need for immediate change and improvement and asked that since the letter was sent and received by Veyo, has the Department noticed any considerate and positive changes in terms of timeliness at the call centers and reduction in complaints. Rod said that the data does show significant improvements in all areas but the Department is still not satisfied with the level of improvements but will continue to work with Veyo to get where the services need to be.

Terri DiPietro from Middlesex Hospital said that sometimes patients must wait between 8 to 9 hours for a pick-up after an emergency department visit and sometimes, Middlesex Hospital pays for taxi rides home for these patients. Is there a way the ASO Veyo can reimburse the hospital for the NEMT services the hospital must provide? Rod's understanding is that Veyo is in discussion in the process for reimbursement of transportation services provided outside of its network. Kelly Phenix who is a Co-Chair of the Coordination of Care Committee said that members of her committee were very disappointed that there we no Veyo representatives at the January meeting. She said that the consumers on that committee wanted to be heard by Veyo on the quality of NEMT services provided since the beginning of the year. Bill Halsey (DSS) said that Veyo was working with operational issues and will be present at the March meeting and that Veyo will be held accountable and that DSS was not shielding or protecting Veyo. DSS is fully holding Veyo accountable and both he and Rod were at the January meeting and they both informed Veyo of what committee members said. DSS wants to verify as much data as possible; i.e. call wait times, so it can be independently verified. Every time a complaint happens, send the data: name, date, telephone number, pick-up time, and Medicaid I.D. number and then an investigation will happen for every incident, not just on an aggregate nature.

### **Action Items**

#### Level of Care (LOC) Guidelines: Autism Spectrum Disorder Services

Terri DiPietro (Co-Chair of the Operations Committee) said the changes to the guidelines were not substantial. Dr. Lois Berkowitz (DCF) remarked that the only changes made were to keep the language generic. Dr. Sabooh Mubbashar said that he was happy that Connecticut had guidelines but he stated that the guidelines did not answer the question of who was eligible for ASD services. Bill Halsey (DSS) said that these guidelines can never be used for a denial of services. Denials have to be based on medical necessity. After a lengthy discussion by many Council Members on flexibility, the vote to accept the guidelines was postponed so that the Operation Committee could have a further discussion and possible change of language for Autism Spectrum Disorder Services. Council Co-Chair Pat Rehmer announced that the Office of Child Advocate and Beacon Health Options will give presentations on Autism Spectrum Disorder Services at the March Council meeting.
