BHP OC Administration

Co-Chair Pat Rehmer convened the meeting at 2:03 PM and welcomed everyone. She then asked for public comments. Hearing none, Pat asked Council Members if they reviewed the May 2019 summary and requested a motion to accept it. Dr. Eliot Brenner made the motion and it was seconded by Dr. Steve Girelli. All voted to accept the summary as written with no nays. Pat then asked the State Agency Partners to give their department reports.

Connecticut Behavioral Health Partnership Agency Reports: Department of Mental Health and Addiction Services –Alyse Chin

Alyse Chin said the department received a level funding (same funding as last year) in the budget with no cuts to services and programs. The Legislature did approve some additional monies but there is no implementation language. For example, there was restored funding for \$1.6 million for grants, mental health, and substance abuse. \$161,000 was restored for personal services which may include cessation for alcohol and vaping for youth 21 years of age. There is also a \$200,000 for managed services line item but without implantation language. Alyse also stated that there is no privatization in this 2-year budget. There was also a low-wage increase for the private not-for-profits (for staff that make less than \$15.00/hr.). The monies for CMHC were restored.

Department of Social Services-Bill Halsey (DSS) and Rod Winstead (DSS)

Bill Halsey reported that in terms of the budget, there was a minor change to the HUSKY A Medicaid eligibility. The income limit for parents is going to 150% FPL to 155%. There were rate increases for Natchaug and some methadone providers. He reminded the Council that DSS has been working on the *Integrated Care for Kids* (InCK) grant (delivery model for children and pregnant women) which they are applied for on June 8, 2019 with Clifford Beers in New Haven. They should know from CMS by December if they won the grant. Bill thanked Alice Forrester (Clifford Beers) and her staff for working all weekend to make sure the grant was ready to submit. He also thanked the state agencies that helped with this very competitive proposal. He believes if this grant is obtained, it will help the entire children's behavioral health system.

Rod Winstead (DSS) sent out the monthly data on **Non-Emergency Medical Transportation services (NEMT)** for dialysis and wheelchair trips. This was distributed to the membership and is posted below. He then handed out another document with a pie chart showing NEMT data for 2018 (also below). He said that NEMT is top priority for the department and it is also on top of the radar for the new commissioner who will begin at the end of June. To date, sanctions have amounted to \$28,500. Co-Chair of the Coordination of Care Committee, Janine Sullivan-Wiley said that the state auditors are conducting an audit on the Administrative Service Organization (ASO), Veyo for their first year of service.



Department of Children and Families – Dr. Stephney Springer (DCF)

Dr. Stephney Springer brought some clarity to some budget options that she reported on from last month. DCF will be launching another track of the differential response system to assist families with underlining issues that resulted in a child protective service report coming to the agency. Children and families who have been identified as a low risk will be offered intensive care coordination to achieve an increase level of stability and thereby reducing the likelihood of future involvement with the department. They are also establishing an enhanced system of care to provide casework community referrals and treatment services for children and youth with serious emotional behavioral health needs. This program is only for families who have not come to the attention of the department for reasons of abuse or neglect.

Judicial Branch – Barbara Lanza (Jud)

Barbara Lanza reported that her department is still looking into details of the budget. It is expected that they will be able to fund another Staff SECURE and Hardware REGIONS program. They have awarded the current RFP (pending for quite some time) for the Hardware SECURE REGIONS program to Community Partners in Action, a company out of Hartford. The facility will be in Hamden with eight beds for boys. They hope it will be ready by early 2020. Functional family therapy employment and vocational services are being funded with RFPs that will be released by summer. Also, the Council for State Government is partnering

with the department on juvenile justice on reform and will make their recommendations for changes in the system ready by next February.

State Department of Education- Charlene Russell-Tucker (SDE)

Charlene Russell-Tucker said there was a release of CT Report Cards that her colleague, Agit reported last month. They can be found on the data portal EdSight Webpage on the SDE Website. It is also on a mobile friendly app that can be downloaded and is accessible and available to a broad audience. Her department would like any feedback that can be given.

Department of Developmental Services - Kathryn Rock-Burns (DDS)

Katie Rock-Burns reported on the Step-down unit that opened earlier this year. It is at capacity five (5) beds and has a waiting list. Every individual is provided with on-going supports after discharge. The biennial budget fully funded their crisis preventions and other intervention initiative programs. They are also having formal partnerships with DMHAS and DCF on how DDS will run their kid services and how they intersect in the Behavioral Health provider community.

Child/Adolescent Quality, Access & Policy: - Steve Girelli and Jeff

Consumer and Family Advisory Council (CFAC) Update -Kelly Phenix

Kelly Phenix reported that DPH came to their meeting and did Data Collection CT that is a survey on service delivery and child health-early childhood disease for the Healthy CT 2020 Initiative. Kelly also announced that CFAC members are planning the 5th Annual iCAN conference with a theme of "Sustaining Communities through True Partnership". It will take place on September 26, 2019 at the Artist's Collective on Albany Avenue in Hartford. They are looking for sponsorship and vendors. At the May meeting, Bill Halsey (DSS) did a demonstration on the literacy of Tele-medicine. He will be returning for the next meeting with a video on tele-health.

- Maureen-O'Neill Davis spoke on the continuum of impact trauma piece for children
- Dr. Bert Plant (Beacon) said that strength of the Council comes from its diverse membership
- Bill Halsey (DSS) talked about overall access and quality: PCMH and PCMH+ Programs
- Charlene Tucker-Russell talked about strategic planning for purpose and strategy
