BHP OC Administration

Connecticut Behavioral Health Partnership Agency Reports: Department of Mental Health and Addiction Services –Alyse Chin

Alyse Chin (DMHAS) reported that the CT BHP agencies received the CMS Substance Use Disorder Planning Grant, also called the Support Act Planning Grant. Details of the grant will be announced at the Alcohol Drug Policy Council (ADPC) meeting in December.

Department of Social Services-Rod Winstead (DSS)

Rod Winstead (DSS) reported that Bill Halsey was at a conference in Washington, D. C. and he will give a presentation on the Substance Use Disorder (SUD) Grant at the December 2019 BHPOC meeting. He also sent out the Key Performance Indicators (KPI) for the latest information data on **Non-Emergency Medical Transportation services (NEMT)**. It was distributed to the members and published on the BHPOC Website. It can also be found below. Council Members still had concerns with Veyo, particularly in the Waterbury region. Rod said that he will bring these concerns back to Veyo to come up with a resolution.



Department of Children and Families – Dr. Stephney Springer (DCF)

Dr. Stephney Springer reported that there are no changes in the department budget. The department is continuing with the implementation of the integrated family care and support program and the voluntary services program.

Judicial Branch – Brian DeLude (Jud)

Brian Delude (CSSD) announced that bids have gone out for the REGIONS SECURE program and CSSD is holding an informational session on the procurement process for residential secure Juvenile Justice Facilities (programs) in Connecticut. A panel made up of Judicial Branch leadership from the Court Support Services and Administrative Services Divisions will lead discussions in an attempt to identify available resources. By listening to input from the provider community, this session is intended to foster the development of creative solutions to meet this challenge. This will be an outreach effort to collaboratively address the requirement of the Judicial Branch's Court Support Services Division to provide appropriate secured facilities for youth aged 14-18 ordered to receive treatment by the Superior Court for Juvenile Matters in a secured facility.

Glen Peterson gave the department report due to the absence of Charlene Russell-Tucker. Attached is the Student Mental Health Resource document was provided to attendees at the Alliance District Symposium last month.

Department of Developmental Services - Kathryn Rock-Burns (DDS)
