

# Health Equity Planning & Culturally and Linguistically Appropriate Services (CLAS)

Technical Assistance Offerings

**Connecting to Care** is a federally funded initiative focused on improving the state's behavioral health system for children. In order to best serve all children with behavioral health needs in our state, the services that children and families might benefit from must be racially just, culturally responsive, and linguistically appropriate.

Building off of the National Culturally and Linguistically Appropriate Services (CLAS) Standards and in alignment with the Connecticut Department of Children and Families (DCF) racial justice framework, we offer a blueprint for child- and family-serving organizations to implement racially just and culturally and linguistically appropriate services that will advance health equity, improve quality, and help eliminate disparities in access and outcomes in children's behavioral health.

Connecting to Care provides technical assistance in a variety of modalities to assist organizations do this using the CLAS Standards and supporting in the development of Health Equity Plans. Health Equity Plans are intended to assist organizations in advancing principles of health equity, improving quality of care and services, and helping eliminate health disparities. Plans developed in collaboration with the Connecting to Care initiative focus on the federal Office of Minority Health's CLAS Standards and align with the DCF's statewide racial justice framework.

Technical assistance is meant to be individualized to organizational context, and participation amongst any of the following activities are at the discretion of the organization. A number of consultants provide technical assistance across the areas of initiation, implementation, evaluation, and sustainability. Technical Assistance is expected to be available from 2020-2024.
