Connecticut Behavioral Health Partnership Agency Reports: Department of Social Services-Rod Winstead (DSS)

Rod Winstead (DSS) gave thanks for the Calendar Invite and congratulated Lori, Carrie and Andrea for their promotions and said that he looks fondly to continuing working with them. He announced that Bill Halsey was in another meeting. He then spoke of legislation related to Children's Behavioral Health and thanked Beacon for data related to the proposed legislation. He reminded the Council that there will be a 60-day advanced notice from CMS when the Public Health Emergency (PHE) will end which may be in June or July. He gave Members the link for the Substance Use Disorder Demonstration Project. It is part of the U.S. Department of Health and Human Services' effort to combat the ongoing opioid crisis, the Centers for Medicare & Medicaid Services (CMS) created an opportunity under its authority. Department of Mental Health and Addiction Services- Colleen Harrington (DMHAS)

Colleen Harrington and newly promoted Deputy Commissioner of DMHAS reported on the 1115 Substance Use Disorder Project and residential providers. Department of Children and Families – Dr. Stephney Springer (DCF)

Dr. Stephney Springer (DCF) announced that the Department's Family First Plan has been approved and is grateful for the feedback on the plan. Negotiations are underway for the expansion of EMPS services and space for community providers. Therapeutic Foster Care is in action.

Judicial Branch – Barbara Lanza (Jud)

Barbara Lanza (CSSD) announced that CSSD has removed the mask requirement for everything except for detention centers and Congregate Care Infirmaries. Encouragement of mask use and social distancing will remain in place.

State Department of Education- Bryan Klimkiewicz, Special Education Director (CSDE)

Bryan Klimkiewicz (CSDE) spoke of the new Individual Education Program (IEP) forms are now in use. See the new IEP website: <u>New IEP/CT-SEDS</u> for the program document template. Before the Pandemic, it was hard to recruit and retain special education teachers and it is more so now, during the Pandemic because special education concerns for Social emotional referrals and are on the rise. Mask mandates are now done locally by district and not by the State. 9-12 remote learning standards are in place just in case of another mass closing of schools.
